379.4 Documents for Sealing:

The application of the official seal to the documents listed in the schedule to the official copy of the minutes was authorised on the proposal of Mr. T. Ambrose and seconded by Mr. T. Maher.

379.5 Finance Reports:

Finance Reports F.287 and F.288 as circulated was discussed.

379.6 Monthly Reports:

6.1 Community Care Committee: Minutes C.343 of meeting held on 9th November, 2000 as circulated, were adopted on the proposal of Mr. M. Fitzpatrick and seconded by Dr. F. Gallagher.

It was proposed by Dr. F. Gallagher, seconded by Mr. J. Coonan and agreed:

"That the Chief Executive Officer should investigate the possibility of getting a representative from the South Eastern Health Board area on the National Cancer Forum".

Radiotherapy: Discussion also took place on the ongoing need for a local radiotherapy service for some 400 patients within the region. It was noted that this was a question of national policy at this stage and that recommendations were awaited. The Chief Executive Officer indicated that he would set aside monies as opportunity arose to create a fund out of which this service might be financed once approved and provided at Waterford Regional Hospital.

6.2 General Hospitals' Committee: Minutes G.347 of meeting held on 9th November, 2000 as circulated, were adopted on the proposal of Mr. G. Byrne and seconded by Mr. T. Ambrose.

6.3 Special Hospitals' Committee: Minutes S.345 of meeting held on 9th November, 2000 as circulated, were adopted on the proposal of Mr. L. Carthy and seconded by Mr. J. Coonan.

It was noted that funding had been allocated in the National Development Plan capital allocation for the replacement of the District Hospital, but that no funds were available for St. Joseph's at this stage.

346.1 Minutes and Matters Arising:-

The minutes of the monthly meeting held on the 9th November, 2000 were adopted on the proposal of Mr. Meaney and seconded by Ms. Long.

346.2 Finance:-

The contents of Finance Report F.287 were noted and discussed. When anticipated additional allocations in respect of Demand Led Schemes, Superannuation, Kosovan Refugee Scheme and Clinical Waste costs are taken into account, there is an excess of expenditure over budget of £442,000. Arising from discussions, with Department officials, additional funding has been made available this year in respect of the oncology service and increased nursing overtime costs. This additional funding together with savings resulting from unavoidable delay in introducing some developments, should result in the Board not exceeding its allocation for the year.

346.3 Overview – Letter of Allocation – 2001:-

The South Eastern Health Board has received its allocation for 2001. The proposed allocation is £377.307m nett. An additional allocation for service developments and other provisions for 2000 received was £32.824m.

The Regional Manager outlined the services and other provisions included in the allocation for 2001. The most significant developments and other provisions include;

- Acute hospital developments, cancer services, continuation of waiting list funding and cardiovascular strategy.
- Services for the elderly and psychiatry.
- Intellectual disability/autism services, physical/sensory disability services, child care, dental services, drugs and food safety service.
- Commission on nursing and nurse training education.

The above financial provisions are significant both in cost and quantum of new service developments. These are being considered in conjunction with existing service levels.

Following this consideration, service development proposals will be incorporated in the service plan, currently being prepared for the January 2001 meeting of the Board.

346.4 Report of the Health Research Board on Irish Psychiatric Hospitals and Units – Activities 1999 – S.S. 131:-

The members noted the contents of this report.

346.5 Clinical Winter Services – Update:-

The Regional Manager updated the Committee on the clinical winter initiatives undertaken by the Board. The Medical Assessment Unit in St. Luke's Hospital is open, nursing home beds have been contracted within the region, community support structures are in place, additional beds have been provided in the District Hospital Gorey, District Ward Waterford Regional Hospital, St. Anthony's Unit, Clonmel.

346.6 Project Updates:-

The Regional Manager informed the Committee that the contract for the new 25 bed day care unit at St. Columba's Hospital, Thomastown would be signed at the January meeting of the Board. All special hospitals projects are on target.

344.1 Minutes and Matters Arising

The minutes of the Community Care committee meeting held on the 9th November 2000 were adopted on the proposal of Mr Deering and seconded by Dr de Souza.

Under item 343.4 the Deputy Chief Executive Officer advised that the independent evaluation of the Ambulance Service is currently being considered by the Ambulance Department. It is anticipated that the report will be available to the committee members for the January meeting.

344.2 Letter of Determination

A copy of the Department of Health & Children's Letter of Determination for health expenditure for 2001 for the South Eastern Health Board was circulated to each committee member. The non-capital determination for this Board for 2001 is £377.307 million. The Deputy Chief Executive Officer discussed the contents of the letter in detail with the committee.

344.3 Finance

The committee noted the contents of Finance Report No. F287 outlining the Board's financial position at the 31st October 2000. It was noted that following discussions with the Department of Health & Children additional funding has been made available this year in respect of the Oncology service and increased nursing overtime costs. This additional funding together with savings resulting from unavoidable delays in introducing some developments should result in the Board not exceeding its allocation for the year. The committee members expressed concerned that the savings in the

Community Care Programme are being used to offset the overspending in the other areas. In relation to Finance Report No. F287 Dr Stacey asked for a reconciliation of credit balances shown. Mr Beegan agreed to obtain this additional information for Dr Stacey on this matter.

The committee also noted the contents of Finance Report No. F288 which outlined details of the letter of determination for 2001.

344.4 Annual Report of the State of the Drug Problems in the European Union, 2000 CS290

The contents of report no. CS290 outlining the annual report of the state of the drug problems in the European Union 2000 were discussed and noted by the committee.

344.5 Aislinn Centre, Ballyragget

The committee noted the contents of the report on the Aislinn Adolescent Addiction Treatment Centre. The Deputy Chief Executive Officer advised the committee that following a recent meeting between the Health Board, the Aislinn Centre and the Department of Health & Children, it was agreed that an independent evaluation be carried out on the centre early in the New Year.

344.6 Asylum Seekers

The committee noted the contents of the report on the number of asylum seekers in the region at the 12th October 2000. The Deputy Chief Executive Officer advised that the number of asylum seekers in the South Eastern region has now risen to 821.

344.7 Sale of Property

The Deputy Chief Executive Officer advised the committee that the Health Centre in Ballyouskill is no longer in use by the Board. On the proposal of Dr Gallagher, seconded by Mr Deering the committee agreed to offer the property for sale by public auction.

344.8 Visiting Committee Reports

The committee noted the contents of the visiting committee reports for

- b) Community Care Centre, Kilkenny

The committee members complimented those involved in the improvements at St Dympna's Hospital in Carlow.

Prior to the commencement of the meeting, the Chairman and members expressed their congratulations to Ms. A. Gee who has been appointed Acting Assistant Director of Nursing at St. Patrick's Hospital, Waterford.

348.1 Minutes

The minutes of the meeting held on 09.11.2000 were agreed on the proposal of Mr. Maher and seconded by Mr. Ambrose.

Matters Arising

- Under 347.1
- Dr. Ormonde expressed his satisfaction that Comhairle na nOspideal had cleared the way for both Consultant Oncologist posts at Waterford Regional Hospital to be advertised.
- Mr. Ambrose asked if any progress had been made with the Local Authority in South Tipperary on the need for an Occupational Therapist to undertake assessments for the Disabled Persons Grants Scheme. Mr. Finnegan will check the position for the next meeting.
- Ms. Johnson asked if the Board's Clinical Winter proposals were implemented and meeting the demand for services. Mr. Finnegan outlined the range of measures taken in each of the Board's Acute service catchment areas and confirmed that the demand is being managed at present.
- In reply to Mr. Maher, the Regional Manager undertook to investigate some criticisms of services at St. Luke's Hospital, Kilkenny in recent weeks.
- The Chairman observed that the Inter-Departmental Report (Post Mortems) had just been published and is now being studied by relevant parties.
- In reply to Ms. Johnson the Regional Manager advised that the WRH Project Team had met twice in recent weeks and that plans are being made for developments over the next four years.

348.2. Letter of Determination 2001

The letter which was received from the Department of Health & Children on 11.12.00 was reviewed along with the accompanying appendix.

There was some disappointment that the funding for shortfalls in existing services did not meet all the Board's requirements. However, there was general satisfaction about the level of funding for new developments 2001 and roll on costs for 2000 initiatives.

Respective funding for the range of acute services was explained by the Regional Manager who compared it to the previous year and indicated the Board's intentions for its use.

Members welcomed funding in particular areas and thanked the Regional Manager for explaining the complexities of the allocation system.

348.3 Service Plan 2001

The Regional Manager advised the Committee that the Board's plan is now at the draft stage. He invited members to highlight any significant issues which they are aware of which should be addressed.

The invitation was welcomed by Ms. Johnson who expressed her concern about the state of St. Vincent's and St. Joseph's Hospital, Dungarvan.

Within the capital allocation/NDP the Board has a sum available for work at St. Vincent's District Hospital but unless there is a separate allocation no funds have been provided to address St. Joseph's Hospital.

348.4 Consultant Manpower

The Regional Manager updated the members on the progress made particularly in the past six months. He listed posts which have been filled, are in the process of being filled and these posts which have been approved on a temporary basis.

When the letter of determination has been considered fully and following Mr. Finnegan's meeting with the Department of Health & Children officials it was agreed that the Committee would discuss the issue early in 2001.

348.5 Oncology Service.

In noting that the new and replacement Consultant posts had been approved by Comhairle na nOspidéal there was some concern that adjustments to the qualifications for the post by Comhairle means the posts will not be advertised until January 2001.

348.6 Additional Waiting List Initiative Funding.

The progress made during the year was commended on and it was agreed that good value had been achieved for the £2.8 m. allocation total.

Mr. Finnegan will be meeting the Consultant Orthopaedic Surgeons to agree on a working programme for a 7th Orthopaedic Consultant under the waiting list initiative and the proposals will be considered by the General Hospitals Committee at the January meeting.

In reply to Mr. Ryan it was agreed that waiting list information could be provided complete with waiting times – but relative factors should be taken into account in the interpretation of the waiting times.

348.7 Report from Hospital Visiting Committee.

The report from the Visiting Committee to Our Lady's Hospital on 23.11.00 was noted.

I hope to have the Tenders back by 31st January 2001 and to sign a contract for its implementation by end of February, 2001.

I expect that the system will be applied progresively from Spring 2001 and by year end any initial difficulties will have been resolved.
