**97/2000****MINUTES OF PROCEEDINGS OF BOARD MEETING HELD ON 7<sup>TH</sup> NOVEMBER, 2000**

The minutes of the proceedings of the meeting held on 7<sup>th</sup> November, 2000, having been circulated, were confirmed on a proposal by Dr. B. Murphy, seconded by Dr. S. Barry.

**98/2000****QUESTIONS TO THE CHIEF EXECUTIVE**

On a proposal by Cllr. E. Byrne, seconded by Dr. B. Murphy, it was agreed to answer the questions which had been lodged.

**1. Cllr. Eric Byrne**

Regarding the Commission to enquire into Child Abuse will the Chief Executive say if he has appointed a Director and/or Professional Counsellors yet to work in this field?

Will he now agree to update the Board on the current position and will he make a statement on this matter?

**Reply:**

A Director for the Counselling Services for Adult Survivors of Child Abuse in South Western Area Health Board has been appointed who will take up duty in mid-January 2001. An additional two counsellors have also been appointed. A further three counselling posts from the former regional service – LARAGH – have also been assigned to the South Western Area Health Board.

The Director and staff will be reviewing the service and locations for the counselling services in the coming months.

**2. Cllr. Eric Byrne**

Will the Chief Executive please outline any financial agreement agreed between this Board and the Doctor members of the Board that allows Doctors to engage Locums while in attendance at Board meetings and will he make a statement on this matter?

**Reply:**

The 1998 national agreement between the Department of Health and Children and the Irish Medical Organisation on a claim under the PCW provides for the payment of locum allowances to general practitioners attending meetings of statutory bodies and GP Committee meetings convened (and verified) by the Irish Medical Organisation.

Accordingly, locum allowances are payable to general practitioners in respect of attendance at meetings of health boards as this would constitute attendance at a meeting of a statutory body.

Payments of expenses to members of the Board must, under law, be in accordance with a scale determined by the Minister for Health and Children with the consent of the Minister for Finance. Any changes in current arrangements would require the approval of both Ministers.

**3. Dr. Siobhán Barry**

Could the Chief Executive explain the formal relationship between the South Western Area Board and the Blessington Children's Centre?

Is this centre owned and operated by Mr. Derek Nally's company, Secureway?

How many children do the Northern, South Western and East Coast Area Boards currently place in this centre?

Are the staff trained Child Care workers, and subject to Garda Clearance?

Is this centre subject to the Social Services Inspectorate?

**Reply:**

This service is operated by Secureway Ltd. Mr. Derek Nally, who was the founder and Managing Director of the company, retired in June 2000. The Managing Director is Mr. Colm Smith. There are two separate distinct sub-divisions within the company – the child care division and the security division. The premises in the Blessington/Naas area are rented and not owned by them. One young person is in a house in the Baltinglass area.

Currently, twenty young people are living in these different locations. The breakdown per Health Boards is as follows:

- East Coast Area Health Board      4
- Northern Area Health Board      8
- South Western Area Health Board    7
- Mid-Western Health Board      1

The staff are not required to have a formal qualification in child care. However, about 50% have a recognised qualification in child care. Other staff have relevant qualifications for working with young people. All staff have to obtain Garda Clearance.

There is no formal service agreement or arrangement between Secureway and any of the three area health boards. Young people are placed on an individual basis. Regular reviews are held, a teacher has been appointed to provide daily tuition and prepare the young people for mainstream education. A staff consultant/trainer has also been engaged by the company.

The Registration and Inspection Service is managed by the Northern Area Health Board on behalf of the three area health boards. The Registration and Inspection Service has made a preliminary visit and outlined the requirements if the service is to be registered as a childcare centre.

This service is an interim measure as the three area health boards are currently developing a wide range of new and alternative services for children and young people in the region.

Mr. Joe Byrne, Chief Emergency Planning Officer, made a presentation to members on "Why Emergency Planning?" (copy filed with official minute).

Members thanked Mr. Byrne for his presentation. The issue of difficulties for the emergency services because of grid-lock on the roads was discussed. Mr. Byrne responded by stating that the Gardaí and other services are examining alternative routes which could be used in emergency situations. He also indicated that the training of motorcycle paramedical personnel who can attend victims on site while awaiting the arrival of an ambulance is currently being examined.
