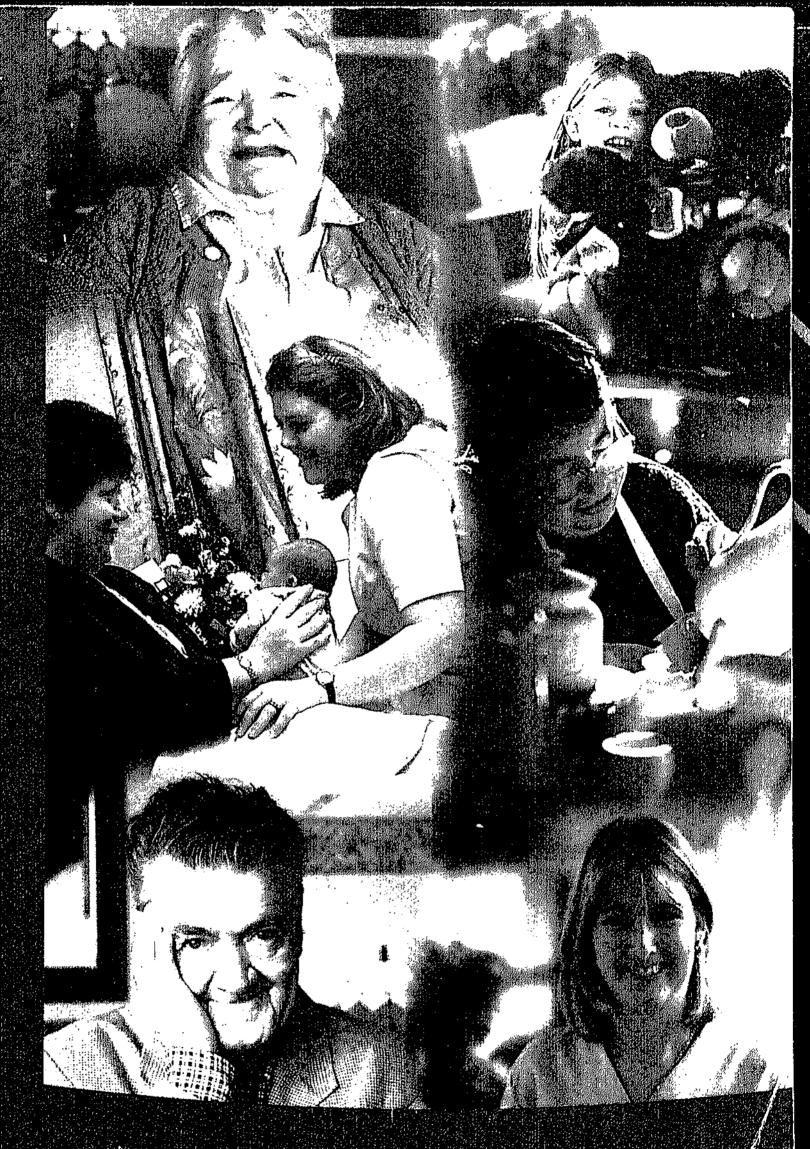

#### A. INTRODUCTION

This manual has been prepared in accordance with the requirements of Section 15 and Section 16 of the Freedom of Information Act, (FOI Act) 1997.

#### A.1. Information Routinely Available

The Southern Health Board currently makes information routinely available to the public in relation to its functions, services and schemes. Such information will continue to be available informally without the need to use the FOI Act. This manual highlights, in relation to each of the Board's activities, where information on the services and schemes is available. The Southern Health Board operates a Customer Information Centre to help answer queries on any of the services or schemes provided by the Board, which can be contacted at 1850 742 000 for less than the cost of a local call from within the Southern Health Board region.

#### A.2. Freedom of Information Act (FOI) 1997

The FOI Act is designed to allow public access to information held by public bodies which is not routinely available through other sources. Access to information under the Act is subject to certain exemptions and involves specific procedures and time limits. This manual provides a guide to the structure of the Board in order to help you access information routinely and under the FOI Act. It is prepared in accordance with the publication requirements set out in Section 15 of the Act.

The FOI Act establishes three statutory rights:

- a legal right for each person to seek access to information held by public bodies;
- a legal right for each person to have official information relating to him/herself amended where it is incomplete, incorrect or misleading;
- a legal right to obtain reasons for decisions affecting oneself

The Act asserts the right of members of the public to obtain access to official information from public bodies which includes Government Departments, Local Authorities and Health Boards etc. to the greatest extent possible consistent with the public interest and the right to privacy of individuals.

#### A.3. General Overview of Section 15

Section 15 of the Freedom of Information Act requires this manual to state in relation to each public body, in this case the Southern Health Board, its structure and organisation, its functions, powers and duties, the services it provides and the procedures for accessing services by the public.

#### A.4. General Overview of Section 16

Section 16 of the Freedom of Information Act requires the Board to make its internal rules, guidelines and procedures in relation to the services and schemes available to the public.

In accordance with this section, the Southern Health Board has prepared a manual containing:

- Details of the services and schemes administered by the Board
- The Legislation governing the provision of the service or scheme
- The rules, policies, guidelines etc., used by the Board in making decisions with regard to these services and schemes
- Information regarding eligibility
- The appeals process

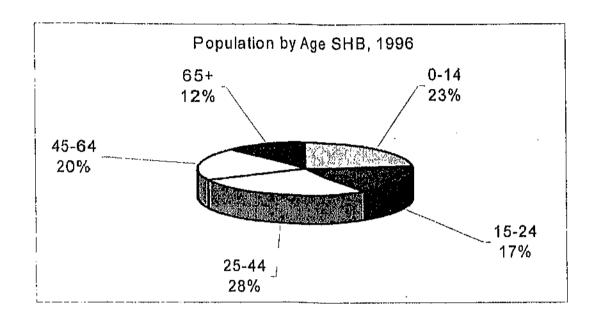

#### Senior Management Structure

The Southern Health Board has recently implemented a new senior management structure, the key features of which are outlined below. The need for a new structure arises from changes in the external and internal environment. It is designed to maximise the potential for strategic development while ensuring that services are delivered at the highest possible standard throughout the region. (See Appendix F. 2)

#### Key features of new structure

- A two tiered senior management structure comprising of an Executive Team and a Corporate Development and Delivery Team. The Executive Team will comprise of five members, namely:
  - Chief Executive Officer
  - Director of Service Delivery
  - Director of Support Services
  - Director of Strategy and Planning
  - · Director of Public Health.
- Developing the detailed structure of each of these departments is the responsibility of the relevant Director. The Corporate Development and Delivery Team will comprise of representatives from the management level immediately below that of the Executive Team.
- The Director of Finance will not be a member of the Executive Team but reports directly to the Chief Executive Officer.
- · Creation of a number of new positions and teams within departments including
  - Director of Service Delivery
  - Director of Support Services
  - Director of Strategy and Planning [Enhanced Role]
    - Planning and Evaluation
    - Monitoring and Commissioning
    - \* Care Group and other specific plan development
    - Quality and Compliance
- Significant restructuring of the existing Strategy and Planning Department to reflect the increasing importance of the role of planning in assisting in the delivery of an integrated focused service. This will result in a new enhanced post of Director of Strategy and Planning being established.

#### C.2. COMMUNITY CARE SERVICES/SCHEMES

#### **Adoption Services**

#### This service will be of interest to the following care group(s)

Child & Family Care Group

#### General Description

The Adoption Department provides a varied range of services to single mothers: maternity services, foreign adoption assessment, tracing, post-adoption counselling, pre-adoption foster-care placements and meeting the requirements of the Adoptions Acts, 1952-1999.

#### Services Provided

- Services to Single Mothers: Hospital based pre and post birth counselling. Pre-adoptive foster placement.
- Foreign Adoption Assessments: As per the 1991 Foreign Adoption Act, this entails social workers carrying out a detailed "couple" assessment, with a one day information session. When the assessment report is completed, and all relevant references, medical certificates and P60s are on file, it is presented to the Southern Health Board when a declaration of suitability and eligibility is given by the Adoption Committee. The report then goes to the Adoption Board.
- Fostering Service: for pre-adoptive placements only. This is a short-term placement, post-birth and pre-adoption process.
- Tracing: this involves substantive inquiries, usually from a couple of sources for example birth mothers, adopted child (likely to be an adult) or putative father, boarded out children.
  - Birth Mothers: interested in finding, identifying or just checking the existence of the babies, now much older and often adults, as to how they are. Some also want to set up contact.
  - The Adoptees: who may want to progress to meeting their birth parents after counselling, or want information about siblings, their whereabouts, status and progress.
  - Relatives seeking information regarding the above.
- Counselling for all those involved in tracing, if they wish to meet.
- The 1988 Adoption Act: including application by foster parents to adopt children long-term in the care of the Health Board.
- Extensive Referrals/Queries: from couples on the waiting lists for Tracing and Foreign Adoptions regarding time frames, and other questions. Responding to information sought by the Adoption Board, U.K., Adoption and Social Services Agencies in Romania, Russia, etc. Re postadoption home visits over three years and other relevant services.

#### **Arbour House Treatment Centre**

#### This Service will be of interest to the following care group(s)

Child & Family Care Group

#### General Description

Arbour House was established in 1984. An alcohol and drug free, non-residential, professional treatment centre, it is a free service to clients with addictions, their families and concerned persons.

The treatment programmes derive their philosophy and models of treatment from the Minnesota Model and the Therapeutic Community approach.

#### Services Provided

- Consultant and Assessment Service individuals of all ages and their families who may have concerns about substance misuse or problem gambling can attend Arbour House for consultation and assessment. This consultation assessment and advisory service evaluates the impact of the substance misuse or problem gambling on the individual, his or her partner, family life and work.
- Education Programme for people living with active addiction this seven week (16 hour) programme where clients acquire an understanding of the nature of addiction and how they can help themselves and the addicted person to deal with the problem. The programme involves (a) lectures, (b) video tape presentations and (c) group discussions.
- Community Drug Teams and Student Assistance Programme as part of the Southern Health Board's Primary Prevention and Community Action Arbour House is actively participating in the setting up of Community Drug Teams and Student Assistance Programmes. Staff at Arbour House are also involved in addiction education programmes for various groups of professionals.
- Employee Assistance Programmes Arbour House has a tradition of working with the public and private sectors in advising on the setting up of Employee Assistance Programmes.
- Adult Treatment Programme this is a 15-week treatment programme based on the Minnesota Model of addiction and treatment and also the community alcohol approach. Clients attend Arbour House for approximately ten hours per week for group and individual therapy. Clients also attend the various fellowships such as Alcoholics Anonymous, Narcotics Anonymous, Gamblers Anonymous. Clients' families and concerned persons attend for conferences and supportive counselling. Following successful completion of this stage, clients attend once weekly for aftercare for a further six months. Individual counselling is also available. Successful completion of the programme is marked by a Graduation Ceremony.
- Young Person's Programme This is a programme offered for adolescents and young adults. The programme is divided into two main phases, "intensive" and "re-entry". The intensive phase lasts for six months. Clients attend a highly structured five-day programme with organised weekend activities. In addition to individual and group therapy, multiple and individual family therapy is available, they also attend various fellowships such as Alcoholics Anonymous, Narcotics Anonymous, Gamblers Anonymous. The re-entry phase, which lasts for 12 months, is primarily concerned with assisting the young persons return to social, family and community life. The purpose of the programme is to bring about profound behavioural changes in the young person. Individual counselling is also available. Successful completion of the programme is marked by a Graduation Ceremony.

#### **Aural Services**

#### This service will be of interest to the following care group(s)

Child & Family Care Group Older Person Care Group Mental Health Care Group

#### General Description

The Board makes aural treatment and aural appliances available for:

- Persons with full eligibility
- Children up to the age of 6 years in respect of defects discovered at child welfare clinics
- Pupils attending national schools in respect of defects noticed at school health examinations

#### Services Provided

The services provided at community level are as follows:

- Referral of children for treatment in respect of defects discovered at child welfare clinics and school health examinations.
- The supply of hearing aids to persons with eligibility for aural services

#### **Access to Services**

#### Child Services

When defects are noticed at child welfare clinics or school health examinations the Area Medical Officer makes arrangements to refer children to:

- the Audiology Clinic at St. Finbarr's Hospital, Douglas Road, Cork for further testing or to the appropriate clinic/consultant if examination or treatment is required.
- a Hearing Aid clinic if a hearing aid is required. Hearing Aid Clinics are provided by the Southern Health Board within the region.

#### Adult Services

Adults with hearing defects are referred by their GP to an Ear, Nose, & Throat (ENT) Clinic. They are referred from the ENT Clinic to a Hearing Aid Clinic if hearing aids are required. Hearing Aid Clinics are conducted by the Southern Health Board.

• Supply and Repair of Hearing Aids

Hearing aids prescribed for patients at a Hearing Aid Clinic are supplied directly to patients by the Southern Health Board. Minor repairs to damaged hearing aids are carried out at the clinics and major repairs are forwarded to the audiology Service, Northern Area Health Board, Dublin.

#### Child & Adolescent Psychiatry Service

## This service will be of interest to the following care group(s)

Child & Family Care Group Physical & Sensory Disability Care Group Mental Health Care Group

General Description

The purpose of the service is to provide a mental health service that is multi-disciplinary and facilitates the healthy development and well-being of children and adolescents and their families. The service is for children and adolescents (and their families/carers) who are experiencing

emotional, psychological or behavioural problems, the severity of which interferes with or threatens their ability to lead everyday lives. Age range 0-15 years is seen for assessment, once referral is made prior to 16th birthday. Expected waiting list time and priority status decision may influence referral acceptance determination. Some adolescents who have been assessed prior to their 16th birthday may continue to be offered a service up to their 18th birthday.

#### Services Provided

- To provide consultation, assessment, diagnosis and treatment of psychological and psychiatric disorders in childhood and adolescence.
- To provide a community-based service responsive to the needs of a designated Southern Health Board population with equal access to all, regardless of sex, race, income, social class or other social/demographic factors.
- To provide teaching and training of students in the multi-disciplinary team professions and also for related professions involved in the treatment and care of children, adolescents and their families.

#### Access to Services

Referrals to this service are accepted from the following:

- Medical Practitioners
- The following Southern Health Board professionals: Social workers, speech and language therapists, psychologists. Referrals must be authorised by a professional of at least senior grade.
- Educational psychologists of the Department of Education and Science and psychologists working with those voluntary bodies in the catchment area of this department which do not have a psychiatric service. Referrals must be authorised by a professional of at least senior grade.

Non medical referrers are asked to liaise with a child's family doctor prior to making a referral. Written referral requests are required. Telephone referrals are accepted in urgent cases to be followed by a confirming letter. Telephone enquiries as to the suitability of a potential referral are encouraged.

#### Child Health Service

#### This service will be of interest to the following care group(s)

Child & Family Care Group

#### General Description

The Child Health Service is provided by an Area Medical Officer (AMO) within a geographical area of the Board. The service is provided to two groups – preschool age children (Child Welfare Service) and school children (School Medical Service).

- Preschool age children (Child Welfare Service)
  - Provide information for child health monitoring and surveillance within the preschool age population.
  - Provide information and advice to parents regarding defects and diseases.
  - Provide health and healthy lifestyles education to parents and children.
- Services for school children (School Medical Service)
  - Screening of primary school children for physical, psychological and educational defects and referral for further assessment and treatment.

- Provide information for child health monitoring and surveillance within the primary school population.
- Advise and deliver the Diphtheria/Tetanus/Pertussis/Polio booster to children
- Advise and deliver the MMR to the primary school-going population.
- Provide information and advise teachers, parents and children regarding defects and disease.
- Provide health and healthy lifestyles education to teachers, parents and children.

#### • Immunisation

An Immunisation Service is provided by General Practitioners who hold a contract for this service with the Board.

- Two vaccinations are given to babies at two, four and six months
- A single injection (5 in 1) to protect against Diptheria, Tetanus, Pertussis (whooping cough), Haemophilus Influenza Type B Disease and Polio
- A single injection to protect against Meningococcal Group C disease
- A further vaccination is given at fifteen months to protect against Measles, Mumps, and Rubella.

#### Access to Services

#### • Child Welfare Service

Child Welfare clinics are held in a number of Health centres and attended by a Public Health Nurse and an Area Medical Officer. Attendance is by appointment and referrals can be made through your local Public Health Nurse; your General Practitioner or by contacting the relevant Area Medical Officer's office for your area.

Any children with identified defects or problems are either monitored by the Area Medical Officer or referred to a specialist service e.g. Paediatric out-patient clinic at a General Hospital.

Child Development Clinics in North Cork, West Cork and Kerry are provided by Area Medical Officers and Public Health Nurses. Each Area Medical Officer provides this service within a designated geographical area. Parents and their children (who are in and around 9 months of age) are invited to attend Clinics by appointment. The children's physical and developmental levels and hearing and vision are checked at the clinics. A limited developmental service is available in Cork City and South Cork.

#### • School Medical Service

Each school is visited annually and all children in selected classes are offered an examination as follows:

Junior Infants Vision screening

Booster (2-in-1 & Polio) vaccination

1<sup>st</sup> Class Vision and hearing screening

6<sup>th</sup> Class Vision screening including colour and vision testing for boys

MMR vaccination for both boys and girls

Children in other classes may be examined if requested by teacher or parent. A questionnaire and a consent form are sent to the parents of these children, prior to the examination.

Children who require psychological or educational assessments are also seen by the AMO and referred to the appropriate agency for testing.

Children with identified defects or problems are monitored by the AMO or referred to specialist services for assessment and/or treatment.

Parents are invited to attend if examination by the Area Medical Officer is considered necessary for their child. They will also be invited to attend when their children are due to get their vaccinations.

#### • Immunisation

All children are eligible to obtain this service which can be accessed through General Practitioners.

Meningitis C: - The aim is to administer this vaccine to everybody between 0-22 years within the next two years. Meningitis C was introduced in October, 2000. It is provided by the G.P.'s for pre-school children and first year college students. Special Meningococcal teams have been organised to administer it to school going children. It is obtained from the G.P. for everybody who does not fit into this category. It is being introduced on a phased basis with priority being given to those most at risk.

#### General Description

Southern Health Board Community Services has four full-time Chiropodists/Podiatrists based in Cork City providing a service to Cork City, North Cork, to Cork University Hospital (Diabetic Chinic only), St. Finbarr's Hospital, Our Lady's Hospital and St. Stephen's Hospital. In West Cork and Kerry the service is provided on a sessional basis.

#### The aim of the service is:

- To improve foot health awareness in the population overall.
- To maintain mobility and independence where this is restricted as a result of acute and chronic foot pain.
- To provide a service to the elderly, disabled and those who suffer from conditions such as diabetes, rheumatoid arthritis and who have poor circulation.
- To develop a strategy involving early intervention to prevent development of risk factors for diabetic foot disease.

- Pain management in the foot.
- Nail surgery.
- Verrucae Treatments
- Diabetic foot-care and continuous assessment.
- Preventative measures by use of customised orthotics.
- Foot-care and foot-wear advice.
- Foot Health Awareness programmes for individuals and groups.

#### **Community Care Social Work Department**

# This service will be of interest to the following care group(s) Child & Family Care Group

#### General Description:

The Community Care Social Work Departments (CCSWD) are an intrinsic aspect of the Community Care Services to promote "the welfare of children in its area who are not receiving adequate care and protection" (Child Care Act, 1991). It works specifically with children whose health, welfare and development has been, or is believed to be, at risk of being avoidably impaired. The Department works together with other services in a co-ordinated approach to promote child welfare and to prevent and detect child abuse. In the first instance this work is supportive of the parents' and wider family's own efforts to provide for the welfare of their children.

- Identification of children or groups of children whose welfare is being avoidably impaired and to provide appropriate responses to promote their welfare.
- Work with the families of children whose welfare is in danger of being avoidably impaired. This takes the form of direct social work intervention, support and facilitating child and parental access to other child care and family support services.
- The investigation, assessment and ongoing monitoring of the welfare of children under the age of 18 years who are suspected of being or who have been, physically, sexually, or emotionally abused and/or neglected.
- Liaison with relevant and associated childcare professionals and agencies to ensure a multidisciplinary approach to the investigation and management of child abuse cases and support of vulnerable families.
- Arrangements for the reception into care of children both through the voluntary consent of
  parents or through Court Orders when such intervention is required. Even when children must be
  received into care it is first investigated whether it is possible for them to be cared for in their
  extended family to preserve family continuity/contact and be minimally disruptive on the
  children's care and development.
- Application for Court Orders e.g. Care Orders (full, emergency and interim), Supervision Orders, Barring Orders, where legal remedies are deemed necessary to protect children.
- Support of fostering, relative or residential placements of children including care planning and reviews of care placements with all parties concerned. Facilitating contact between children in care and their birth families.
- Provision of accommodation and support to homeless teenagers, under the age of 18 years who
  do not require to be received into the care of the Health Board.
- To convene, chair and minute Child Protection Case Conferences in accordance with the Health Board Protocol.
- To provide ongoing training for Health Board staff in the Child Care area.

#### Access to Services

Ideally if a person has concerns about the care of children they should raise these concerns and their reasons with the parents and could suggest that assistance is available from the Public Health Nurse and CCSWD. It is always easier to intervene if the family concerned see the need for and request assistance rather than having an unsolicited visit concerning alleged child ubuse/neglect. Where for any reason this is not possible and the concerned person wishes to advise the CCSWD of a concern relating to someone else whom they believe requires social work intervention, they can do so by (or in order of preference): -

- 1. Personally calling to the relevant area team. A duty social worker is available office hours to meet new families experiencing difficulties. It is preferable (though not necessary) to make an appointment.
- 2. Phoning the relevant area team and asking to speak with the duty social worker or if the family concerned is already receiving a service, to the allocated social worker.
- 3. Via the Gardaí: if there is a serious and immediate risk to a child, the Gardaí can intervene and will formally notify the CCSWD of the need for its intervention.
- 4. By letter, if they wish to record their concerns to the CCSWD in writing. Letters should be addressed to the relevant Area Team Leader. (see list below)

#### **Community Psychology Services**

#### General Description

Psychology services are provided by clinical psychologists based in three Community Care Service areas. These services provide appropriate assessment and therapy to children, adolescents and their families who present with a broad range of social and psychological problems. The psychology services' objectives operate within the framework of the Child Care Act (1991) which places a statutory obligation on Health Boards to promote the welfare of children (0-18 years) not receiving adequate care and protection.

#### Services Provided

- The role of the psychologist is to undertake a thorough assessment involving the child and his/her family or carers in order to plan a programme of psychological therapy appropriate to their needs. Assessment involves a number of interviews and may include the use of various psychological tests, i.e. intellectual, personality, behavioural. Intervention may involve working directly with the child/adolescent, with parents or carers, with the family, with teachers or a combination of these. The type of intervention will depend on the nature and extent of the problem and may include individual or group therapy, family support, crisis intervention, parent counselling and training in parenting skills. Psychologists also liaise closely with other Health Board professionals and are available for consultation, training and support.
- Types of Problems Clinical Psychologists are trained to provide a comprehensive psychology service and to address a range of psychological problems. Some of these problems include:

## General Description

- The Community Welfare Service is designed to help relieve social distress and where possible to
  prevent its reoccurrence by providing an important support role within the personal social service
  structure.
- There are two main aspects to the role of the Community Welfare Service:
  - income maintenance
  - welfare and information in the community.
- The service is provided by the Health Board's Community Welfare Officers and administrative staff, and supervised by the Superintendent Community Welfare Officers.

# Services Provided

- Financial Support: is provided through the administration of the Supplementary Welfare Allowance Scheme. Types of payment include:
  - Basic Supplementary Welfare Allowance.
  - Rent and Mortgage Interest Supplements.
  - Diet and Heat Supplements.
  - Other Supplements, e.g. for necessary travel, budgeting.
  - Exceptional Needs Payments.
  - Back to School Clothing and Footwear.
  - Urgent Needs Payments.
- Financial Assessment: Investigating and reporting on the financial eligibility of people for the various health and welfare services administered by the Board, e.g.:
  - Medical Cards.
  - Nursing Home Subventions.
  - Blind Welfare Allowance.
  - Mobility Allowance.
  - Rehabilitation Maintenance Allowance.
  - Housing Aid for the Elderly.
  - Infectious Diseases Maintenance Allowance.
  - Outstanding Hospital Accounts.
- Information and Advice: Informing consumers of the health, welfare and other statutory services that are available and assisting them to avail of these services. In addition, information is provided on the services of the voluntary and community organisations in the area. Community Welfare Officers also give information talks to local community groups in their area.
- Referrals: As part of overall service provision, Community Welfare Officers act as referral agents to other service providers within the Board, such as Public Health Nurses, Social Workers and external agencies, such as the Department of Social, Community & Family Affairs and Local Authorities.
- Advocacy: This involves acting as an intermediary on behalf of customers with organisations such as other Government Departments, Local Authorities, Credit Unions, Lending Agencies and the E.S.B.
- Budgeting: Working in conjunction with the Money Advice and Budgeting Service (MABS) and other agencies, Community Welfare Officers provide a money management advice service, which utilises their knowledge and resources.

# **Drugs Payment Scheme**

## General Description

Section 59 (2) of the Health Act, 1970 requires that the Southern Health Board helps financially, the person whose expenditure on prescribed drugs and medicines in relation to their requirements purchased from a retail pharmacist for a specified period exceeds a specified amount as determined by regulations.

#### Services Provided

A new Community Drug Scheme, the Drugs Payment Scheme, was introduced on 1<sup>st</sup> July, 1999. This new scheme replaced the former Drug Cost Subsidisation Scheme and Drug Refund Scheme.

Under this scheme an individual or family will only have to pay the first £42 (52.33) per month of the cost of prescribed medicines approved under this scheme. Medical Card holders are unaffected by the scheme.

For the purpose of this scheme, family members are husband/wife, or a man and woman who are not married to each other but are co-habiting as husband and wife and dependants under 18 years and those between the ages of 18 & 23 years who are not included on medical cards and who have no income of their own.

#### Access to Services

Residents of Cork and Kerry who are not Medical Card Holders and who wish to avail of the benefits of the new scheme must register with the Southern Health Board. Applicants must complete a registration form, which is available from local Health Board offices, pharmacies, doctors' surgeries and other health service outlets. Completed registration forms should be returned to appropriate Community Care Area Headquarters

Once the registration form has been processed each person named thereon will receive a plastic swipe card which they must present when having prescriptions filled at a community pharmacy. Pending the introduction of a facility whereby pharmacists can access a central database to confirm amounts already paid, all members of a family should use the same pharmacy throughout a month to obtain prescribed medication. Evidence in the form of receipts for dispensed items in a calendar



month must be presented to allow the pharmacist establish the amount, if any, to be paid by a family in that month. Credit for amounts in excess of £42 (53.33) paid in a calendar month by members of the same family can be claimed from a community pharmacy by presenting all receipts at the time of the next dispensing.

Where circumstances dictate that a family has to use a second pharmacy within the month up to £42 (€53.33) will also have to be paid to the second pharmacy. A refund of this amount can be claimed from the local Health Board Community Care Area Offices (listed below).

It is essential, except in the case of the United Kingdom, to produce form E111, which should be obtained from Board before travelling. Persons intending to travel should also obtain information (available from the Board's staff listed under Contact Names and Addresses below), regarding the emergency medical services provided in the country, or countries, which they intend to visit.
- Visitors to non-EU and non-EEA countries should arrange appropriate private medical insurance cover.
- Information on Form E112 (Assistance towards the cost of Medical Treatment outside the State Scheme) is included in the Acute Hospital Services section (see page 84).

## Environmental Health Services.

## General Description

Environmental health personnel fulfil duties under listed legislation. Their role includes preventative and promotional measures to protect the health of the population through food and environmental health controls.

#### Services Provided

The principal functions are grouped as follows:

#### Food Control:

- Inspection, examination and verification of food controls within food premises.
- Monitoring of bacteriological and compositional quality of the regional food supply and water supplies within food premises.
- Registration and licensing of various classes of food premises.
- Assessment of compliance of food supply with food additive and labelling legislation.
- Investigation of complaints of unfit food and food borne illness.
- Provision of food hygiene education courses to various classes of food enterprises.
- Provision of certification to ships under International Health Regulations.
- Inspection of food imports.
- Monitoring of shellfish supplies.
- Liaison with other food control agencies.

#### **Environmental Health Control:**

- Pest control advisory and legislative control.
- Licensing of premises selling listed poisons.
- Monitoring of smoking controls in public places and enforcement of tobacco legislation.
- Sampling of private water supplies, advisory service on remedial works.
- Investigation of environmental health complaints, liaisons with Local Authorities.
- Monitoring of fluoridated public water supply.

# **Community Services Multi-Disciplinary Functions:**

- Housing Aids for the elderly assessment and approval of remedial works and grants.
- Nursing Home inspections.
- Pre-school inspections.

#### Access to Services

Food Safety: The public may make complaints to Environmental Health Officers (EHOs) regarding hygiene and safety aspects of food and food service.

Food Businesses: Clients planning to open food businesses may seek advice from EHOs on legislation controls.

Hygiene Education: Clients requiring hygiene education for food workers may contact EHOs regarding the availability of food hygiene courses.

Ships Agents: Ships agents requiring certification under International Health Regulations may contact Principal EHOs at their offices.

Food Control Agencies: Other Food Control Agencies may contact Principal EHOs at their offices.

Environmental Health: Complaints of non-compliance with Tobacco Regulations may be made to EHOs. Advice on suitability of private waters may be sought from EHOs.

Fees: Fees are charged for ships inspections, water testing, Public Analyst's reports, registration, licensing of food businesses and food hygiene courses.

Complaints: All complaints received from the public are investigated. Reports may be issued to the complainant subject to Environmental Health legislative confidentiality constraints.

The Assessment Unit for Child Sexual Abuse in the Southern Health Board is located in the Family Centre, St. Finbarr's Hospital, Douglas Road, Cork. It was established in 1988. The staff of the Unit is multi-disciplinary, consisting of medical, social work, nursing and secretarial personnel.

#### Services Provided

- Assessments: The Family Centre provides an assessment service for children referred because of concerns or allegations of sexual abuse. The assessments are carried out by medical and social work staff.

# Food Microbiology Laboratory

## General Description

The Food Microbiology Laboratory at St. Finbarr's Hospital, Douglas Road, Cork serves the Cork and Kerry area and includes providing services for some local authorities within that area, i.e. Cork County Council and Kerry County Council.

#### Services Provided

- Microbiological testing of foodstuffs to include milks, foods and waters.
- Testing of water samples for the public.
- Information on significance of test results.

#### **Access to Services**

- The current fee is £15 (19.05) and must accompany the sample.
- One follow-up sample is tested free of charge.
- Request form appropriately filled must accompany the sample.
- A contact telephone number is requested so that a verbal report can be given if necessary.
- A written report is sent to the client on completion of tests.
- Any queries of a technical nature will be answered by the Technical Manager.
- The Laboratory accepts samples of foodstuffs for microbiological testing from the Boards' Environmental Health Officers only.

# General Medical Services Scheme

# This service will be of interest to the following care group(s)

Child & Family Care Group Older Persons Care Group Physical & Sensory Care Group Mental Health Care Group

## General Description

The purpose of the scheme is to provide persons who are unable, without undue hardship, to arrange General Practitioner Medical and Surgical Services for themselves and their dependants.

#### Services Provided

## Medical Services

The general practitioners provide the following services free of charge for all eligible persons on their panel of patients:

- Consultation services at their surgeries or at patients' homes, as the circumstances require.
- Proper and necessary treatment of a kind normally undertaken by a General Practitioner.
- Family Planning service including information and advice on natural methods of Family Planning, on barrier methods of contraception, on oral contraceptives and on LU.C.D.s
- Furnishing medical certificates in respect of any illness noticed during examination, which is reasonably required by the patient, or the parent in the case of a child.
- Prescribing drugs, medicines and appliances.
- Dispensing drugs/medicines for patients who opt for this service, in cases where the Practitioner has only one centre of practice and it is three miles or more from the nearest retail pharmacist.

### · Choice of Practitioner

Eligible persons are entitled to choose, from the panel of participating medical practitioners, the practitioners they wish to provide services, subject to the following conditions:

- The medical practitioner selected must have his/her main centre of practice within 7 miles from the applicant's home. This condition does not apply however in certain individual cases, such as where there is no participating practitioner with his/her main centre of practice within 7 miles of applicant.
- The number of eligible persons on the practitioner's approved panel of patients must not already exceed 2,000. In exceptional circumstances the Board, in consultation with the organised medical professions, may decide not to apply this limit.
- The practitioner agrees to accept the applicant for inclusion on his/her panel of patients.

# • Change of Medical Practitioner

 A patient wishing to transfer from the panel of one General Practitioner to another can do so by completing a transfer application form, provided that the General Practitioner to whom the transfer is required is willing to accept the patient on his/her panel and signs the application form to this effect.

#### • Temporary Residents

- Eligible persons who move temporarily and are residents in an area not served by their own practitioners are entitled to receive all the services available under the scheme from any practitioner in the area participating in the scheme.
- If the move extends to more than 3 months then residence in the area is no longer regarded as temporary, and they should apply for a medical card or a change of doctor as appropriate.

### • Emergency Treatment

- All practitioners are required within reason to provide emergency services for eases arising from accidents or otherwise, for eligible persons who are not on their panel. This applies

only, however, when such persons' own practitioners are not available to provide the services.

#### Access to Services

- Applicants should complete:
  - An application form and have it signed by the doctor of choice.
  - A financial assessment form.
- Both forms should be sent to the local Community Welfare Officer, together with the documentation specified on the forms.
- The Community Welfare Officer completes a financial assessment report and makes a recommendation with regard to eligibility.
- If the application is approved, a medical card is issued and the General Practitioner is notified to include the applicant on his/her panel.

# Liberty Street House - Services for Young People Out of Home

This service will be of interest to the following care group(s) Child & Family Care Groups Mental Health Care Group

## General Description

Liberty Street House (L.S.H.) endeavours to meet the needs of young people who are out of home by providing a comprehensive range of services in partnership with voluntary and statutory agencies. We aim to assist young people who are out of home to move out of homelessness - facilitating and supporting their return home where appropriate. Supporting the transition into sustainable accommodation, self sufficiency and independent living as appropriate to each young person's ability and need, with high, medium and low supports as necessary. Liberty Street House provides a service to the six Health Board Area Social Work Teams.

#### **Services Provided**

Liberty Street House (L.S.H.), formerly the Homeless Adolescent Unit, is in operation since 1995 and endeavours to meet the needs of young people and to fulfil the Southern Health Board's responsibilities under Section 5 of the Child care Act, 1991. Services provided are as follows: -

- (a) Assessment including accommodation needs, family background, social history, behavioural problems, emotional needs, history of care and life events.
- (b) Direct work with young people out of home, those at risk of being so and their families in line with the care plan devised for the young person
- (c) Consultation service to Social Workers in the Southern Health Board in relation to the issue of people out of home
- (d) Co-working cases with the Area Social Worker
- (e) Interagency liaison and networking with community based services
- (f) Service development/planning to ensure a comprehensive service delivery
- (g) Statistical analysis assisting in measuring the extent of the problem and in planning the services required

An increasing number of services and disciplines are incorporated within the structure of Liberty Street House. The team currently consists of Social Workers and Community Child Care Workers, a Public Health is being recruited. The following allied services can be accessed through Liberty Street House: -

Adolescent Sexual Health Team – a multidisciplinary team with a target group including young people involved in prostitution and girls who are out of home and pregnant. Promotion of Sexual Health amongst identified at risk groups.

Domestic Violence Social Worker – provides direct social work intervention for women who are or have been experiencing domestic violence. Engages with area teams where domestic violence is a factor in child protection cases. Provides advice and information on domestic violence matters.

Aftercare Research – a research and implementation officer has completed research on procedures, protocols and structure required for delivery of a quality service, and has outlined a clear programme for the support of young people in need.



Child Care Worker - researching the establishment of a Health/youth Café

Unaccompanied Minor Asylum Seekers – the social worker has drawn up a policy for dealing with separated children seeking asylum. Assessment of needs with regard to accommodation, education, training, religion and culture.

Service Development

<u>Pathways</u> – opened in August 2001, provides emergency residential care, respite care, outreach and aftercare support to young boys aged 14 – 17 years.

<u>Supported Accommodation Scheme</u> – scheme involves a young person residing in a family home where they would have their own room and access to cooking and laundry facilities.

<u>Parkview</u> – The purpose of this service would be to provide homeless young people with an opportunity to live in semi-independent accommodation. The Board is currently finalising the lease of a facility suitable for this purpose.

# **Long-Term Illness Scheme**

# This service will be of interest to the following care group(s)

Child & Family Care Group Older Persons Care Group Physical & Sensory Care Group Mental Health Care Group

General Description

Section 59 (3) of the Health Act, 1970 allows for persons who are not holders of a medical card or a drugs refund card and who suffer from a condition that is designated as a long-term illness to obtain prescribed drugs, medicines and medical and surgical appliances, in relation to that condition, free of charge.

# Services Provided

Persons suffering from any of the following long-term illnesses - mental handicap, mental illness (for persons under 16 years only), phenylkentonuria, cystic fibrosis, spina bifida, hydrocephalus, haemophilia, cerebral palsy, epilepsy, diabetes mellitus and diabetes insipidus, parkinsonism, multiple selerosis, acute leukaemia and muscular dystrophies - may seek inclusion in this scheme and, if eligible, will be issued with a Long-Term Illness Scheme Booklet and provided free of charge with drugs and medicines and medical and surgical appliances which are prescribed for the treatment of that particular illness.

# Access to Services

Application forms are available from the Southern Health Board – to be completed by the applicant and the General Practitioner. The GP is required to certify the condition for which the applicant is seeking cover. He/she must also state the current medical requirements together with the dosage and quantities needed. A numbered authorisation card will then be issued to the applicant showing the long-term illness for which appropriate medication may be supplied. The card must then be presented to the patient's GP to have the prescription entered thereon. This is then presented to the Pharmacist when the patient wishes to have his/her medication dispensed.

# Special Housing Aid for the Elderly

# This service will be of interest to the following care group(s)

## General Description

The Southern Health Board may arrange for the carrying out of an approved scheme of works where an application is received from, or on behalf of an elderly person living alone in unsanitary or unfit conditions.

#### Services Provided

The primary aim of works done under this Scheme is to render a house occupied by the elderly weatherproof and comfortable for the occupants. Repairs to a chimney or fireplace, the provision of water and sewerage facilities, minor roof repairs and attention to doors and windows to guard against attacks may be considered under the Scheme.

# Access to Service

- An application for this special aid can be made to the Southern Health Board by the occupant of the premises requiring improvement or by any person (e.g. voluntary body, relative, doctor, priest, public health nurse, etc.) on their behalf. Where an application is made on this basis an Environmental Health Officer from the Southern Health Board will contact the occupant or the person acting for him/her to assess the case. If the application is approved, arrangements can then be made to have the work carried out.
- Applicants qualifying for other statutory grants (e.g. Disabled Persons Grants, Essential Repairs
  Grants these grants are organised by the Department of the Environment) will not normally be
  included in the Scheme. Repairs to local authority houses are also not normally included in the
  scheme.
- Application forms are available from Community Care Services Area headquarters. Application forms should be completed by the occupant or person acting on their behalf. An estimate for the proposed works from a registered builder should accompany the application.

· Having examined the applications, the Southern Health Board will approve certain works and notify the applicant of their decision. The final decision as to who qualifies and the value of the works to be aided under the programme rests with the Southern Health Board in all cases. Works should not under any circumstances be commenced or a contract entered into prior to the receipt of written approval.

Subvention: This is a payment made by the Health Board in certain circumstances towards the cost of private nursing home care for dependant persons. Persons making an application for a subvention towards the cost of such care will have to be (a) sufficiently dependent to require maintenance in a nursing home and (b) be unable to pay any or part of the cost of maintenance in a nursing home.

Subvention payments will be made directly to the nursing home of the applicant's choice provided the nursing home is registered in accordance with the Health Nursing Homes Act, 1990, the Nursing Homes (Care and Welfare) Regulation 1993 and the Nursing Homes (Fees) Regulations, 1993.

Registration: Nursing Homes are required to be registered by the Board in accordance with the Nursing Homes Act 1990 and the Nursing Homes (Care and Welfare) Regulation 1993 and Nursing Homes (Fees) Regulations, 1993. To fulfil the criteria of the registration procedure Nursing Homes are inspected by an Inspection Team which is chaired by a Senior Area Medical Officer.

#### Services Provided

• Subvention: An assessment of the applicant's dependency is carried out and the maximum rates of Subvention payable are as follows (with effect from 1" April 2001):

- Maximum Dependency £150.00 (€190.46) per week
- High Dependency £120.00 (€152.37) per week
- Medium Dependency £90.00 (€114.28) per week

The actual rate of the subvention paid will depend on the degree of nursing care required which will be assessed on an individual basis. The personal income and assets/savings of the applicant and that of his/her spouse or partner will also be taken into consideration in deciding the amount of subvention required.

- For members of religious orders, financial assessment will relate to personal income or assets.
- Subvention may be refused:
  - If the applicant is assessed as not requiring maintenance in a nursing home or the applicant has assets of more than £26,000 (€33,013.19) excluding his/her principal residence.
  - If applicant's principal residence (where assessable) is valued at £75,000 (€95,230.36) or more and if their annual income is £5,000 (€6,348.69) or more.

Applicant's principal residence is assessable if it is not occupied by spouse/children under 21 years or relative in receipt of Disabled Persons Maintenance Allowance, Blind Pension, Disability Benefit, Invalidity Pension or Old Age Pension.

Registration: Inspections are carried out and advice is given regarding qualification of Nursing Homes for registration. All homes where more than two dependant persons are cared for <u>must</u> be registered with the Health Board. A certificate of Registration must be displayed in a public place in each registered Nursing Home.

#### Cork University Hospital (CUH)

Cork University Hospital, previously known as Cork Regional Hospital, is the principal teaching hospital attached to University College Cork - the Medical School in Cork City. It has 553 beds and is managed by the Southern Health Board. Cork University Hospital operates as part of a city-wide group of hospitals including St. Finbarr's Hospital, Erinville Hospital and St. Mary's Orthopaedic Hospital. The Management Team at Cork University Hospital is also responsible for Mallow General Hospital. Staff from this hospital group also provide clinics at other hospital locations both within and outside the Board's immediate areas of Counties Cork and Kerry.

The annual budget for the Cork University Hospital Group exceeds £80m (101,580,000) of which 75% constitutes pay costs and the balance non-pay. Cork University is the only Level 1 trauma centre for the Republic of Ireland - an accreditation given because of the very wide range of specialities delivered by the hospital. The University Hospital treats 30,000 in-patients per annum and well over 100,000 out-patient attendances annually. One of two undergraduate schools for dentists in the Republic of Ireland is located in the grounds of Cork University Hospital. This facility was transferred to this site in the 1980's from the North Charitable Infirmary. The Dental

School is run by University College Cork with qualifications conferred by the National University of Ireland.

Five of the hospitals form Cork University Hospital and Associated Hospitals Group, namely Cork University Hospital, St. Finbarr's Hospital, St. Mary's Orthopaedic Hospital, Erinville Hospital and Mallow General Hospital.

An Executive Management Board was set up in 1997 for this Group (excluding Mallow General Hospital which comes under the management of Mr T. McNamara, General Manager. CUH & Associated Hospitals Group) and consists of:

# St. Finbarr's Hospital

- St. Finbarr's Hospital comprises of a group of separate buildings spread over a 26 acre site. The original buildings date from the 1830's. Further blocks were added in the 1950's and the elderly rehabilitation wards were purpose-built in the 1970's.
- The hospital has 444 beds in use, accommodating the following specialities:
  - Services for the Elderly
  - Maternity Services
  - Children's Services
  - Psychiatric Services, including Services for the Elderly Mentally Infirm
  - Community Care Services
  - Young Chronic Sick Unit
  - Tuberculosis Unit

# Erinville Hospital

- The hospital has a long history of earing for women and their families: the first lying-in hospital opened in 1779 and has been operating on its present site since 1898.
- As well as maternity and neo-natal services the Erinville Hospital also provides a pregnancy related gynaecological service, as well as infertility, uro-gynaecological and child health services.

# Maternity Services at Erinville and St. Finbarr's Hospitals

 Erinville and St. Finbarr's Hospitals serve Cork City and County, parts of Kerry and some outlying counties. They provide obstetric care to women and paediatric care to new-born babies.

- The service is consultant-led upon referral from GPs and caters for ante-natal, intra-partum and post-partum care with specialised follow-up care for infants, led by Consultants in Neonatology and in Paediatrics.
- While presently on separate sites, plans are at an advanced stage for amalgamation of the two units in a purpose-built maternity unit at Cork University Hospital.
- Services provided at the two units include:
  - Ante-natal and post-natal clinics
  - Miscarriage clinics
  - Paediatric follow-up clinics
  - Midwives clinics
  - Gynaecology clinics
  - Colposcopy clinics (cervical examination) at St. Finbarr's Hospital
  - Liaison Public Health Nurse Service
  - Maternity Social Work Service
- The Southern Health Board College of Midwifery is located at St. Finbarr's Hospital. Clinical placement of students is divided between St. Finbarr's and Erinville Hospitals.

#### St. Mary's Orthopaedic Hospital (SMOH)

- St. Mary's Orthopaedic Hospital is a 125 bedded hospital. It is divided into 5 Block Units plus an Operating Theatre complex.
- It provides Orthopaedic Services for persons requiring joint replacement and other complex elective orthopaedic surgery. Joint replacement, arthroscopic surgery, minor orthopaedic procedures and plastic procedures are performed in the Theatre complex.
- SMOH provides in-patient services for post-trauma patients transferred from Cork University Hospital. It also provides a service for Plastic Surgery and caters for clients from other Health Board regions.

#### Mallow General Hospital (MGH)

- Mallow General Hospital is a 77- bedded acute hospital, an additional 5 beds are available to deal with medical and surgical day eases.
- It provides the following services:
  - Acute Medical and Surgical facilities including Ear, Nose & Throat Surgery.
  - Accident & Emergency Services 24hr Accident & Emergency Department with an Ambulance base and helipad.
  - Out-patients Services
  - Physiotherapy Services
  - Laboratory Services
  - X-ray Services
- It serves a population of approximately 75,000 people, mainly in the North Cork and South Limerick areas. This hospital comes under the management of Mr. T. McNamara, General Manager, Cork University Hospital.

# Bantry General Hospital (BGH)

- Bantry General Hospital is an acute hospital with 110 beds, which meets the needs of the community in the West Cork area.
- The hospital treats both public and private acute medical and surgical patients. It also has:
  - Coronary and Intensive Care
  - Respite and Care of the Elderly
  - Casualty Service
  - Day Case Service
  - Out-patient Clinic Service with Medical, Nursing and Allied Health Services input.

# Tralee General Hospital (TGH)

- Tralee General Hospital is an acute hospital facility for both public and private patients, providing routine and emergency medical services mainly, but not exclusively, for the population of County Kerry.
- Tralee General Hospital has 369 beds and provides the following services:
  - General Medicine
  - Medicine for the Elderly
  - General Surgery
  - Orthopaedics
  - Obstetrics & Gynaecology
  - Ear, Nose & Throat
  - Psychiatry 1 4 1
  - Paediatrics
  - In/Out-patient Clinic Services with Medical, Nursing and Allied Health Services input.
- It also provides Long-Stay Extended Care Services and Respite Services for the Elderly. This latter service is as arranged by the Public Health Nursing Service.
- The hospital provides a wide-range of in-patient and out-patient services under the clinical supervision of consultants who include visiting consultants from Cork University Hospital, Mercy and Community Services (Ophthalmic).

Information booklets, which outline in more detail the services available at each hospital, may be obtained on request by contacting the hospitals.

# Acute Hospital Services Provided

The services provided in the Board's Acute Hospitals are many and varied. They can be broadly categorised into four main headings:

- Medical Services
- Nursing Services
- Allied Health Services
- Support/Non-Clinical and Other Services

#### **Medical Services**

The Acute Hospital Services of the Southern Health Board provide services in the following specialities

### **Accident & Emergency Service**

This service provides care for victims of accidents and emergencies and support for their families. It offers specialised care from a multi-disciplinary group of services. At CUH 50,000 patients per annum are seen. The department is also a National Centre for Maritime Emergency Services.

#### Anaesthetics

This department provides pre-operative, intra-operative and post-operative management of patients requiring anaesthesia for surgery. It also provides an acute and chronic pain service. The National Malignant Hyperthermia Investigation Unit is based at C.U.H.

#### Cardio-Thoracic Surgery:

This department deals with heart problems both medical and surgical.

#### Dental and Oral Surgery:

This speciality deals with the diagnosis and treatment of diseases and defects of the oral and facial region. It encompasses dental surgery, oral surgery and facial surgery.

#### Dermatology:

This department specialises in the diagnoses and treatment of skin disorders.

#### Diabetology:

This speciality involves the treatment of diabetes.

#### Ear, Nose & Throat:

This speciality involves the treatment of conditions relating to the Ear, Nose and Throat.

#### Endocrinology:

This speciality deals with the study of the glandular system and hormones.

#### Gastroenterology:

This service specialises in the study of the stomach/intestines & their diseases.

#### General Medicine:

This service encompasses all the medical specialities such as Cardiology, Rheumatology, Endocrinology, etc.

#### General Surgery:

This service involves the treatment of diseases, injuries and deformities by manual and operative methods.

#### Geriatrics & Medicine for the Elderly:

This branch of medicine concentrates on the diagnosis (incorporating Clinical Age assessment) and treatment of age-related problems.

#### Haematology

This speciality involves the study of blood disorders and the treatment of same.

#### Hepatology:

This speciality provides care for patients infected by the Hepatitis C virus.

#### Infectious Diseases:

This speciality involves the diagnosis and treatment of infectious diseases.

#### Neonatology

This speciality is concerned with the diagnosis and treatment of disorders of the new-born infant.

#### Nephrology

This department deals with Renal (kidney) problems.

# (Clinical) Neurophysiology/Neurology:

This speciality deals with the Nervous System and its diseases.

#### Neurosurgery:

This speciality deals with injuries and diseases of the brain, spine etc.

#### Obstetrics/Gynaecology:

These specialities are concerned with the management of pregnancy and childbirth and the treatment of conditions and diseases of reproductive organs in women.

# Oncology (Cancer)/Radiotherapy Services:

This service for the treatment of patients with cancer works closely with the palliative care service. Treatment is given on an in-patient & out-patient basis.

#### Ophthalmology:

This speciality is concerned with the study of the physiology, anatomy and pathology of the eye.

#### **Orthopaedics**

This branch of medicine is devoted to the study and treatment of the skeletal system, its joints, muscles and associated structures.

#### Paediatrics:

This branch of medicine is concerned with the development and care of children. Its specialities are the particular diseases of children and their treatment and prevention. Specialist clinics, as follows, are held for children:

- Cystic Fibrosis
- Paediatric Diabetes
- Cardiac Problems
- Spina Bifida/Orthopaedic Paediatrics
- Cleft Lip & Palate
- Asthma

#### Pain Relief Clinic:

This clinic specialises in the treatment and control of pain under the supervision of a Consultant Anaesthetist.

#### Palliative Care:

This is the continuing active total care of patients and their families by a multi-professional team at a time when the medical expectation is not to cure and the primary aim of treatment is to prolong life. The goal of palliative care is the highest possible quality of life for both patient and family. Palliative care responds to physical, psychological, social & spiritual needs. Where necessary, it extends to support in bereavement.

#### Pathology

This speciality involves diagnosing, monitoring, and controlling diseases in association with other specialities.

#### Plastic Surgery/Burns:

Plastic Surgery is a speciality that deals mainly with soft tissue trauma and re-construction. This includes the initial treatment of most hand, leg and facial injuries, and occasionally secondary reconstructive procedures. This may involve micro-surgical operations, which are of long duration and labour intensive. Plastic Surgery is also involved in the treatment of congenital deformities such as cleft lips and palates, hypospadias and congenital hand anomalies. The excision of cutaneous malignancies and the re-construction of any secondary defect are also performed. Plastic Surgeons

re-construct breast deformities following mastectomy, and occasionally perform, other anaesthetic procedures such as breast reduction surgery, rhinoplasty and prominent ears.

- As part of the service, there is a designated Burns Unit in Cork University Hospital.
- Plastic Dressing Clinics.
- Cleft lip and palate clinics.

Psychiatry:

This branch of medicine deals with causes, treatment and prevention of mental, emotional and behavioural disorders.

Radiology:

This branch of medicine is concerned with radioactive substances and using techniques of visualisation for the diagnosis and treatment of disease using any of the various sources of x-rays including specialist scanning/imaging services e.g. Ultrasound; Barium; C.T.; Nuclear Medicine; Neuro-Vascular Angiography; I.V.P.

Respiratory Medicine:

This branch of medicine is concerned with the diagnosis and treatment of chest/lungs/breathing problems.

Rheumatology:

This speciality involves the care of patients with Arthritis, back pain, Lupus disease and related conditions. It also involves a Juvenile Paediatric Rheumatology service, research in Osteoporosis and bone-density testing.

Urology:

This branch of medicine is concerned with the study of the anatomy and the care of the urinary tract in men & women.

Vascular Surgery:

This speciality deals with treatment of conditions pertaining to blood vessels.

#### **Nursing Services**

The mission of the nursing staff is to provide 24-hour quality nursing care in a compassionate manner ever mindful of the dignity and individuality of each patient and family. This means delivering care based on up-to-date nursing knowledge. The promotion of self-care and education of the patient are a key nursing function towards the achievement of well being. Nursing roles and responsibilities are defined for those nurses involved in nursing management, nursing education and in nursing practice.

Specialist Nursing Services are provided in the following clinical care areas:

- Breast Care
- C.A.P.D. (Continuous Ambulatory Peritoneal Dialysis)
- Clinical Haematology
- Coloproctology
- Cystic Fibrosis
- Diabetics
- Hepatology
- Infection Control
- Intrevenous Care
- Oncology
- Pain Control
- Palliative Care

- Renal Counselling
- Stomatherapy
- Urodynamics

#### **Allied Health Services**

#### Department of Audiological Science

This department provides a programme for new-born hearing screening, evaluates hearing for patients of all ages, offers electro-physiological tests of balance and ear function and provides guidance and recommendations for those with hearing loss and tinnitus.

#### **Chiropody Service:**

This service deals with problems of the feet, primarily for patients with Diabetes and elderly patients.

#### Clinical Nutritionists/Dieticians:

Dieticians/Nutritionists are trained in the use of scientific principles of nutrition in health and disease. The aim of treatment is to cure or alleviate the patient's condition by dietary means and/or to support the patient nutritionally while undergoing other treatments or investigations. Working with families and other carers is often integral to the process.

#### E.C.H.O./E.C.G.:

This department, as part of the Cardiology Diagnostic service, specialises in echocardiographs & electrocardiographs

# E.E.G./Clinical Neurophysiology Service:

Under the direction of the Clinical Neurophysiologist, the technology staff in this department carry out both routine and non-routine E.E.G., E.P., surface E.M.G. recording, E.M.G. and nerve conduction studies. They also organise and provide a video telemetry E.E.G. monitoring service.

#### Occupational Therapy:

This service provides treatment for physical & psychological conditions through the medium of specifically selected activity to provide optimum independence in all areas of living. The purpose of Occupational Therapy is to maximise the fit between what the individual wants and needs to do and his/her ability to achieve this whenever illness, ageing or accident has disrupted his/her life.

#### Orthoptic Service:

This clinic specialises in the correction of visual axes of the eye. Orthoptists are specially trained in the diagnosis and non-surgical treatment of children and adults with squints.

#### Pathology Service:

The Pathology Department (Laboratory Services) diagnose, monitor and control diseases in association with the medical profession. The department provides services for in-patients, outpatients & GPs. Departments within the Laboratory Service include:

Histology: This department is concerned with the examination, both naked eye and microscopic, of tissues and cells for diagnostic and screening purposes. This laboratory provides a service in all aspects of general histopathology and includes

Neuropathology: which is the examination of nervous tissue.

Cytopathology: which is the study of individual cells and small amounts of tissue from all systems including a smear screening service for the detection of precancerous conditions of the cervix.

Electron microscope: where minute amounts of tissue are examined under a powerful microscope.

Immunopathology: which refers mainly to the detection of antigens and antibodies in tissues and individual cells.

Auto-immune serology: concerned with the analysis of sera for various auto-antibodies.

The department also provides an autopsy service. The service is provided by consultant histopathologists, non-consultant hospital doctors, technical staff and secretarial personnel.

Microbiology: The Microbiology (Bacteriology) department is concerned with the isolation and identification of micro-organisms such as bacteria, fungi, and parasites. These organisms can then be tested against a range of antibiotics to determine which will be best for treating the patient. Where micro-organisms can be difficult to isolate or grow (e.g. viruses) then a blood sample could be tested for antibodies to specific organisms.

Haematology: This department deals with:

Analysis of blood samples for quantitative and qualitative abnormalities of its cellular constitution.

Laboratory investigations into abnormalities found, e.g. Haematinic assays, haemaglobinopathy investigation, red cell enzymes etc.

Analysis of plasma for defects in coagulation and anti-coagulation pathways both hereditary and acquired.

The operation of the hospital blood bank, and ante-natal blood group investigation.

Bone marrow and peripheral blood stem cell transplantation.

Diabetes monitoring.

Biochemistry: To assay a large number of constituents in body fluids (mainly blood and urine) in order to aid diagnosis and monitor treatment. These include:

Routine Clinical Chemistry e.g. cardiac, liver function tests, glucose, etc.

Lipid analysis e.g. cholesterol, triglyceride, lipoprotein, etc.

Hormone analysis e.g. thyroid function, infertility tests, etc.

Specific proteins e.g. immunoglobulin, acute phase proteins, etc.

Therapeutic drug monitoring e.g. Dijoxin, etc.

Allergy

Blood Bank: This department is responsible for serologic testing, together with collecting, processing and storing blood to be used for transfusion and other purposes.

#### Pharmacy:

The pharmacy provides drugs and drug information to the wards and departments of the hospital. This department has full control over procurement, storage and dispensing of all pharmaceutical products for all in-patients & some categories of out-patients, the main aim being to promote the safe, effective & economical use of drugs.

#### Phlebotomy:

This service deals with the taking of blood samples for analysis by the laboratories.

#### Physiotherapy:

This service adopts a physical approach to rehabilitation techniques that aim to maintain or regain a client's optimum level of physical, mental & emotional well-being as well as preventing or delaying the onset of illness or disability. Physiotherapy can input into any condition that compromises physical capability e.g. neuromuscular, musculo-skeletal, cardiovascular & respiratory conditions, developmental abnormalities plus maternity services & incontinence problems. The service is provided on both an in-patient and out-patient basis.

# **Pulmonary Function Unit:**

This department performs pulmonary function testing (PFT), which is a technique that measures lung function.

# Social Work Services

#### Medical Social Work:

Medical Social Workers provide a service to patients and their families where illness and medical care/treatment are complicated by social & emotional problems.

# Maternity & Paediatric Social Work:

The Maternity & Paediatric Social Worker provides a service from antenatal stage to post delivery offering counselling, support, advocacy, practical assistance, information and mediation. There is a particular focus on the under 18 age group.

This service is available to both the Erinville Hospital and St Finbarr's Hospital (Maternity Unit).

# Speech & Language Therapy Department:

This department provides a comprehensive service on an in-patient and out-patient basis for varied speech & language difficulties including Cleft Lip & Palate and Velopharyngael anomalies. The therapists assess, diagnose and manage children or adults who present with a communication and/or developmental or acquired swallowing difficulty with their main focus being the bringing about of positive gain in both communicative and social well-being. The Department of Speech & Language Therapy at C.U.H. supplies a service to:

Cork University Hospital: Children & adults (In-patients & Out-patients).

St. Finbarr's Hospital: Service to the elderly

Mallow General Hospital

Erinville Hospital

# X-Ray Department/Radiology:

Services are provided for in-patients, out-patients and those referred from GPs (by appointment only) & from other hospitals. General radiography & specialist services (in some hospitals) are available with 24-hour on-call service for A&E and in-patients.

# Support/Non-Clinical and Other Services

## **Administration Department:**

The Administration Departments provide clerical and administrative support in the following areas, as appropriate to each hospital:

- General Administration Office including Payroll & Accounts Department.

- General Manager & Deputy General Manager's Office, including support for the Executive Management Board.

- Nursing Administration including clerical support for the Matrons/Directors of Nursing.

- Non-consultant doctors/Medical Recruitment/Personnel Department.

- Complaints/Risk Management Department.

- Switchboard provides a 24-hour service, 7 days a week, for both incoming and outgoing calls.

- The Supplies Department provides a professional material-management service to the hospitals. All supplies are purchased & stored in this department. Service contracts for medical and other equipment are negotiated. In some cases, a stationery and photocopying facility for users is provided.

The Administration Department also administers the Assistance towards the cost of Medical Treatment outside the State Scheme:

# Assistance towards the cost of Medical Treatment outside the State Scheme

General Description

Provision of assistance towards the cost of medical treatment outside the State for persons requiring services that are not available in the Republic of Ireland. The applicant must normally reside in the Southern Health Board area (Cork City, Cork County and County Kerry).

#### Services Provided

Assessment of each application in accordance with EU and Department of Health and Children procedures. Giving of advice, facilitation and issue of documentation as appropriate in each case.

#### Access to Services

- Subject to the assessment procedure (as mentioned above), the service is open to all, irrespective of eligibility under the Health Acts or public/private status in this country.
- The patient applies to the Board by completing an "application form for assistance towards the costs of medical treatment outside the state" and submits it to the Board together with a letter from the referring hospital consultant.

#### Ambulance Service

The primary role of the Ambulance Service is to provide pre-hospital emergency care and transport for the sick and injured. It provides the Health Board's primary response in major emergencies.

The Ambulance Service also provides a routine transport service for non-emergency inter-hospital transfers and clinics.

The overall management of the Ambulance Service is the responsibility of the Chief Ambulance Officer. Additionally, there are two Ambulance Transport Supervisors, one Deputy Transport Supervisor, one Training Officer, and Administrative Officer and eight Leading Ambulance Controllers.

There are two ambulance control centres based at Cork University Hospital and Tralee General Hospital with ambulance bases at:



Cork City:

Cork University Hospital, St. Finbarr's Hospital and St. Mary's Orthopaedic

Hospital.

Cork County:

Macroom, Mallow, Midleton, Clonakilty, Skibbereen, Castletownbere,

Bantry, Kanturk, Millstreet, Fermoy and Youghal

Kerry:

Tralee, Kenmare, Killarney, Dingle, Caherciveen and Listowel.

#### **Chaplaincy Service**

Chaplains are attached to the hospitals on a full-time or part-time basis for Roman Catholic services. Chaplains for other denominations are available as required/requested.

#### **CSSD Service**

This department produces all of the sterile packs and other sterile items used throughout the hospital e.g. gloves, needles, syringes, catheter packs etc. Equipment for sterilising in the department includes an Ethyline Oxide Steriliser, a Disinfector, washing machines & dryers and Autoclaves. The aim of the department is to provide cost-effective, guaranteed sterility of their products.

#### Maintenance Department

This department provides continuous daily maintenance both inside and on the grounds of the hospitals. The staff are also involved in the upgrading of wards and departments on an on-going basis. A 24-hour on-call service is available. A Maintenance Officer, with the support of engineering staff from the Board's headquarters, heads this Department.

#### Medical Library

The library is run by U.C.C. at Cork University Hospital and provides access to a broad range of Medical and Nursing books, journals etc. This is an "in-house" service and is not open to the public. A library is also located at Tralee General Hospital for the convenience of the Board's staff.

#### Medical Records/Patient Services Department

The staff in this department provides support for the issue, storage and retrieval of patients' medical records for:

- Out-patients' clinics
- In-patient services on a 7-day week basis
- Research & teaching
- Audit of services
- Hospital In-Patient Enquiry System (H.I.P.E.)

Reception, typing and clinical support services are also provided for the Out-patients clinics, Medical Teams, Admission Areas, Radiology, Accident & Emergency Department, Laboratories, Ward Clerking, Social Work Department, Ophthalmic Unit, Patient Records Library and Central Appointments Department.

Attendant/Housekeeping Service: this service's responsibilities include general cleaning duties throughout the hospital to create a hygienic & safe environment for patients, staff and visitors throughout the hospitals.

Catering Service: this service provides a catering service to in-patients, out-patients, hospital staff and visitors. The catering staff have two main areas of responsibility:

- The kitchen staff process food and supervise the distribution of meals to wards.
- They are also responsible for the provision of food to the out-patient cafeteria and the main hospital canteen.

Linen Service: this service is responsible for the distribution of linen throughout the hospital. A repair service, the upkeep of screens and curtains, and "special" requirements for theatres/physiotherapy are all made & supplied by this department.

Portering Service: provides a service to all hospital wards, theatres, out-patients and other departments as the need arises, including transportation of patients. Ad hoc duties are provided by House Portering staff such as the collection of linen, waste, carrying of equipment etc.

Post Service: this service is responsible for the sorting and co-ordination of the collection and delivery of all post, parcels and flowers within the hospital.

Security Service: this service provides routine patrols to protect staff, patients and property, investigate theft and violent disturbance in conjunction with the Gardaí and perform traffic duties.

#### Access to Acute Hospital Services

Patients can access services by:

- Referral by General Practitioner/Family Doctor to, for example, Out-patients Department and Accident & Emergency Department for emergency admission.
- Self-referral Accident & Emergency service only.
- Referral from Out-patient Clinics.
- Referral from other hospitals.
- Referral from Consultant's private rooms.

#### General Description

The aim of the Board's Mental Health Service is to meet the specific needs of persons suffering from mental illness in an appropriate and high-quality care setting, and to provide them with the opportunity to maximise their potential in personal, social and economic terms.

Guided by the recommendations contained in the report "Planning for the Future" and the concepts and principles contained in the Strategy document "Shaping a Healthier Future", the Board is restructuring the provision of services for the mentally ill through the ongoing development of our existing hospital based services and the introduction of new community based services.

# Acute Hospital Care

Patients admitted to the acute hospital service in Mental Health facilities of the Health Board must be in accordance with the Mental Treatment Act 1945 as:

- Voluntary patients
- Non-Voluntary patients:

Temporary patient

Person of Unsound Mind

#### **Voluntary Patients**

These are persons who enter the Mental Health hospital of their own free will. Voluntary Medical Card patients are entitled to services free of charge. Persons under 16 years in this category must have a GP referral letter written within the previous 7 days and a patient/guardian must sign the admission form.

Voluntary patients must give 72 hours notice when they wish to discharge themselves from hospital.

#### Non-Voluntary Patients

Clients who are unwilling or unable to accept treatment and require treatment are admitted in one of the following categories:

#### Temporary patient

This category is used to when it is believed that the patient requires for their recovery not more than six months.

An application for admission must be made by a relative or some other recognised person and signed by a medical practitioner and also signed by a hospital medical officer.

#### Person of Unsound Mind

This category is used when it is believed that the patient requires for their recovery more than six months treatment. An application for admission can be made by a relative or in the absence of a relative, any other person, such as a Community Welfare Officer or a Garda Officer. The application must be signed by a Medical Practitioner and the Hospital Medical Officer.

Charges for Acute Psychiatric Hospital care are similar to those applying to Acute General Hospital care:

- Category 1 eligibility applies to persons who are given a medical card, if they satisfy a means test based on personal income. The entitlements included in this category are all inpatient public hospital services in public wards including consultant services and all outpatient public hospital services. After 30 days charges will apply under the Health (Charges for In-patients) Services (Amendment) Regulations 1987.
- Category 2 eligibility relates to persons who do not qualify for a medical card. The entitlements are as for Category 1 above, but subject to certain charges - see Health In / Out-Patient charges Amendment Regulations 1997 and after 30 days, charges will apply under the Health (Charges for In-patients) Services (Amendment) Regulations 1987.

# Clinical Psychology Services

General Description

The Psychology team is an integral part of the Adult Mental Health Services. It operates as part of the multidisciplinary team across in-patient and out-patient and community based services.

#### **Community Based Residences**

General Description

In general, residential facilities are required for those persons who, for various reasons, cannot live in their own homes. The types of residences are as follows:

• High Support:

These units, with 24-hour nursing care, provide accommodation for long-stay patients discharged under the Mental Treatment Act and new long stay patients. Long-stay care is thus provided in the community as an alternative to long stay care in a psychiatric hospital.

• Medium / Low Support:

Medium and Low Support Hostel places are provided in Units for long-stay patients with low dependency level in the community. The psychiatric nurse visits the patients regularly.

#### Services Provided

Access to:

- Out-Patient Clinics
- GMS Cardholders GP services etc.
- Day Facilities
- Training Workshops

#### Access to Community Based Services

## Long-Stay Residential Care/Continuing Care Units

#### **Out-Patient Clinics**

#### **TrainingCentres**

General Description

Training centres play an essential role in the Board's policy on Rehabilitation by responding to the increasing demand for Community based services which enable people with disabilities to participate in a training regime which is both stimulating and rewarding. Training centres are located throughout the Board's catchment areas European Regional Development Funds (Capital) and European Funds have facilitated the implementation of successful training programmes for clients with varying disabilities.

#### Services Provided

- Training: may include woodwork, catering, social skills, upholstery, needlework, computers, literacy, numeracy, desktop publishing, horticulture and picture framing.
- Rehabilitation: skills of independent living, e.g. money management, laundry, flat maintenance, use of transport and communication facilities.
- Sheltered Work: subcontract work for local firms, supervised by Health Board staff.

Access to Training Centre Services

The majority of attendees are referred from the other Mental Health facilities of the Board and have psychiatric disabilities. Referral of clients with Mild Mental Handicap, Physical Disability and Cerebral Palsy are also accepted through General Practitioners, and through the National Rehabilitation Board. Access is based on clinical needs and there is no charge. A Training Allowance is paid to all clients, £10(12.70)-£20(25.39) per week, in addition to Social Welfare entitlements. As the National Rehabilitation Board will cease to exist during the year 2000, new structures will be put in place by the Southern Health Board to facilitate ongoing access to this service

#### **Intellectual Disability Services**

#### General Description:

- The objective of the Intellectual Disability Service is to develop the person with mental handicap to the maximum of his/her potential. Services are being developed in line with the recommendations of the review group on Mental Handicap Services, "Needs and Abilities" (1990) and as outlined in the National Health Strategy 1994.
- The Health Board as statutory authority has responsibility for the provision, development and coordination of services to persons with intellectual disability in the region. In the Southern Health Board area, as in other Health Board areas, there is a long tradition of voluntary service provision and the role of the voluntary sector in services to persons with intellectual disability is fully acknowledged by the Health Board. The Health Board responsibilities in respect of this service are fulfilled by the provision of services directly by the Board but also to a very significant extent by the funding of 11 voluntary agencies to provide such services on our behalf.
- A formal regional, planning and consultative process is in place involving the Board and all the
  agencies. This structure ensures that there is a partnership between the service providers with the
  aim of providing a planned and developed, quality driven service, focused on the needs of
  individuals at local level.

# D. Accessing Information outside the Freedom of Information Act 1997

#### D.1. Introduction

As a matter of policy, the Southern Health Board supports the right of an individual to see what information is held about him or her by a health agency, consistent with the right to privacy and the public interest.

#### D.2. Making the Application

Access to records and information held may be sought by a number of different means.

- Discussion between Patient/Client and/or their family and the health service provider and information provided routinely.
- · Accessing records administratively.
- Making an application under the Freedom of Information Act.

#### **Routine Access**

The Southern Health Board currently makes information routinely available to the public about its functions, services and schemes. Information leaflets, guidelines, application forms and other general information will still continue to be available without the need to use the FOI Act.

#### **Administrative Access**

Access to records containing personal, medical or clinical data should generally be provided administratively. Therefore it may not be necessary to use the FOI Act to obtain this information. This form of access will be known as "Administrative Access Application". All administrative access applications must be in writing and forwarded to the relevant staff member where the record is held.

# D.3. Exceptions to Administrative Access

Where access to a record or information <u>cannot</u> be provided to you directly under administrative access you will be informed of this and advised of the option of making an application under the FOI Act. Likewise, certain information may be of such a sensitive nature that requests for access can only be dealt with under the FOI legislation.

#### D.4. Other Mechanisms for Access To Records

Information and Records are the property of the agency of which they are held, i.e. the Southern Health Board and are kept under strict security and apart from the circumstances above, may only be removed from the Health Board under the following conditions: -

Upon a Court Subpoena

Search Warrant

Court Orders

Garda Investigations

Request and/or Investigation by the Information Commissioner or Ombudsman

By an Officer authorised in writing by the Minister

Current statutory secrecy provisions in Health legislation may apply to the disclosure of information. Therefore, the release of such records/information will be made on the grounds of public interest and on the basis of upholding, enforcing and/or administering the law.

# E ACCESSING INFORMATION UNDER THE FREEDOM OF INFORMATION ACT 1997

#### E.1. Introduction

Under the Freedom of Information Act, 1997, you are entitled to seek access to information not otherwise publicly available. You have a right to:

- seek access records held by the Health Board;
- correct personal information relating to yourself held by the Health Board where it is inaccurate, incomplete or misleading;
- · access reasons for decisions made by the Health Board directly affecting you.

The following records come within the scope of the Act:

- all records held by the Health Board which were created after 21 October 1998;
- any record created before 21 October 1998 if this record is necessary for understanding a record created after 21 October 1998;
- all personal information about you which is held by the Health Board, regardless of when the records were created;
- personnel records of Health Board staff.

Personnel records held by the Health Board may be accessed by employees or ex-employees. Current staff can access records created three years before the commencement of the Act, and any earlier records liable to be used in a way that might adversely affect the interests of the member of staff concerned while former members of staff have no time constraints on access to records.

# E.2. Making an Application under the Freedom of Information Act, 1997.

Requests for information under the Freedom of Information Act 1997 should normally be made in writing. In preparing your request, you should follow these guidelines:

State that your request was made under the Freedom of Information Act. No legal formulas are required; it is sufficient to mention the name of the Act, or that you are making a "freedom of information" request. If you request records which are only available under the Act, without explicitly mentioning the Act, you will receive a phone call/letter from the Southern Health Board informing you of this, and offering assistance in the preparation of a valid request.

- Provide sufficient information You should provide enough information to enable Health Board staff to identify the records requested.
- · Provide full personal contact details including contact telephone number.
- · Be prepared to provide identification as required.

# How Freedom of Information Applications Are Processed

The Freedom of Information Act sets down strict time limits for the processing of your request:

- You should receive an acknowledgement of your request within two weeks of receipt of your request;
- You should receive a reply to your request within <u>four</u> weeks of receipt of your request. However the Southern Health Board may extend this period if:
- your request relates to a very large number of records

Of

- a large number of requests for the same record(s) have been made

.

- the records relate to a third party who may have to be contacted.
- If the period is extended, you will receive notice of this before the end of the initial four-week period, and the reasons for the delay will be given.
- If the Health Board considers that your request should have been sent to another public body, the request shall be forwarded to that body, and you will be notified that this has happened. This must be done not later than two weeks from the receipt of your request. Your request will then be treated as though you had sent it to the second public body on the date on which it was forwarded by the Health Board.
- If the Health Board holds some, but not all, of the records you have requested, then you will be sent a letter informing you of this, and supplying the name(s) and contact details of the other bodies from whom you should request those records not held by the Health Board.

#### If your request is granted:

- · You will receive a letter stating that your request has been granted;
- You will be told the name of the person dealing with your request;
- You will be told the day on which access to the relevant records will be granted, and the manner in which it will be granted;
- You will be given details of the fee, if applicable.

#### If your request is refused:

- You will receive a letter stating that your request has been refused, and giving reasons for the refusal:
- You will be informed of your rights of appeal and review, as set out below.

#### E.3. Rights of Review and Appeal

The Act sets out a series of exemptions to protect sensitive information, where its disclosure may damage key interests of the State or of third parties. Where the Health Board invokes these provisions to withhold information, the decision may be appealed. Decisions in relation to deferral of access, charges, forms of access, etc. may also be appealed. Details of appeals mechanisms are as follows:

#### Internal Review

 $\mathcal{L}$ .

You may seek internal review of the initial decision, which will be carried out by an official at a higher level, if:

- you are dissatisfied with the initial response received, e.g. refusal of access, form of access charges, etc.
- you have not received a reply within <u>four</u> weeks of your initial application. This is deemed to be a refusal of your request and allows you to proceed to internal review. (See also reasons for extending this period as mentioned above).

A request for internal review must be submitted within four weeks of the initial decision. The Health Board must complete the review within three weeks. An internal review must normally be completed before an appeal is made to the Information Commissioner.

# Review by the Information Commissioner

If following completion of the internal review your request has still been refused in part or total, you may seek independent review of the decision by the Information Commissioner. Also, if you have not received a reply to your application for internal review within three weeks, this is deemed to be a refusal and you may appeal to the Information Commissioner.

Appeal to the High Court

A party to a review by the Information Commissioner or any other person affected by the decision of the Commissioner following such a review may appeal to the High Court on a Point of Law only.

#### E.4. Fees

Fees may be charged as follows:

- In respect of personal records, no fees will be charged for copying the records requested unless a large number of records are involved.
- In respect of other (non-personal) information, fees may be charged for the time spent in efficiently locating and copying records, based on the standard rates in operation at the time of the request. No charges may apply in respect of the time spent by public bodies in considering
- A deposit of 20% may be payable where the total fee is likely to exceed £40 (50.79). In these circumstances the Health Board must, if requested, assist the member of the public to amend the request so as to reduce or eliminate the amount of the deposit.

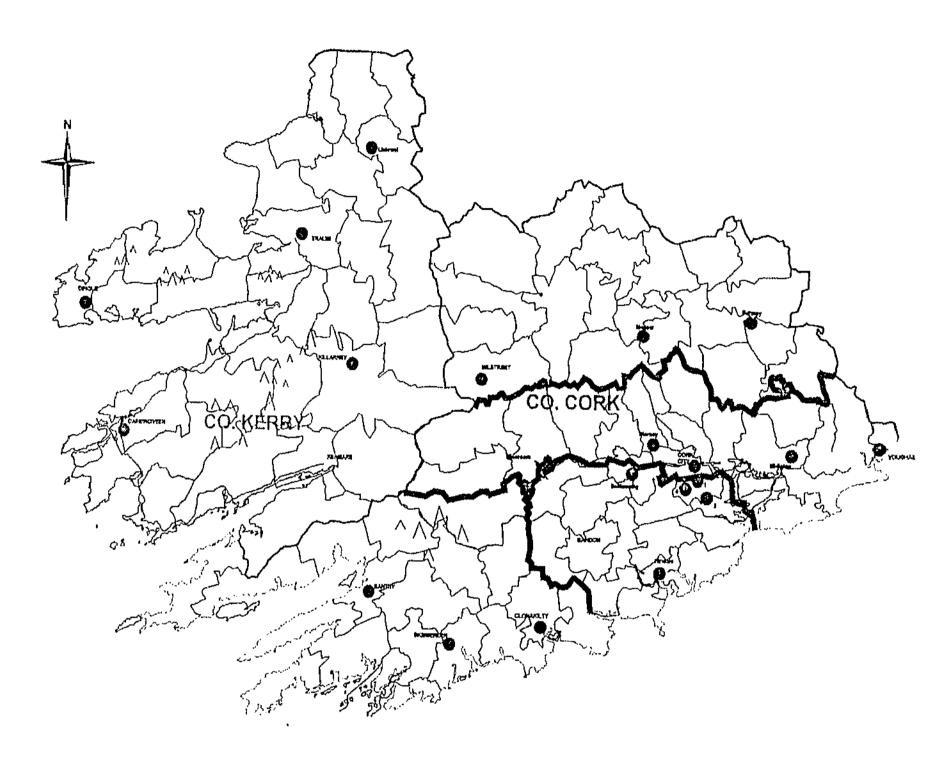
Charges may be waived in the following circumstances:

- Where the cost of collecting and accounting for the fee would exceed the amount of the fee;
- Where the information would be of particular assistance to the understanding of an issue of
- In the case of personal information where such charges would not be reasonable having regard to the means of the requester.

# APPENDIX F.1. MAP OF SOUTHERN HEALTH BOARD REGION



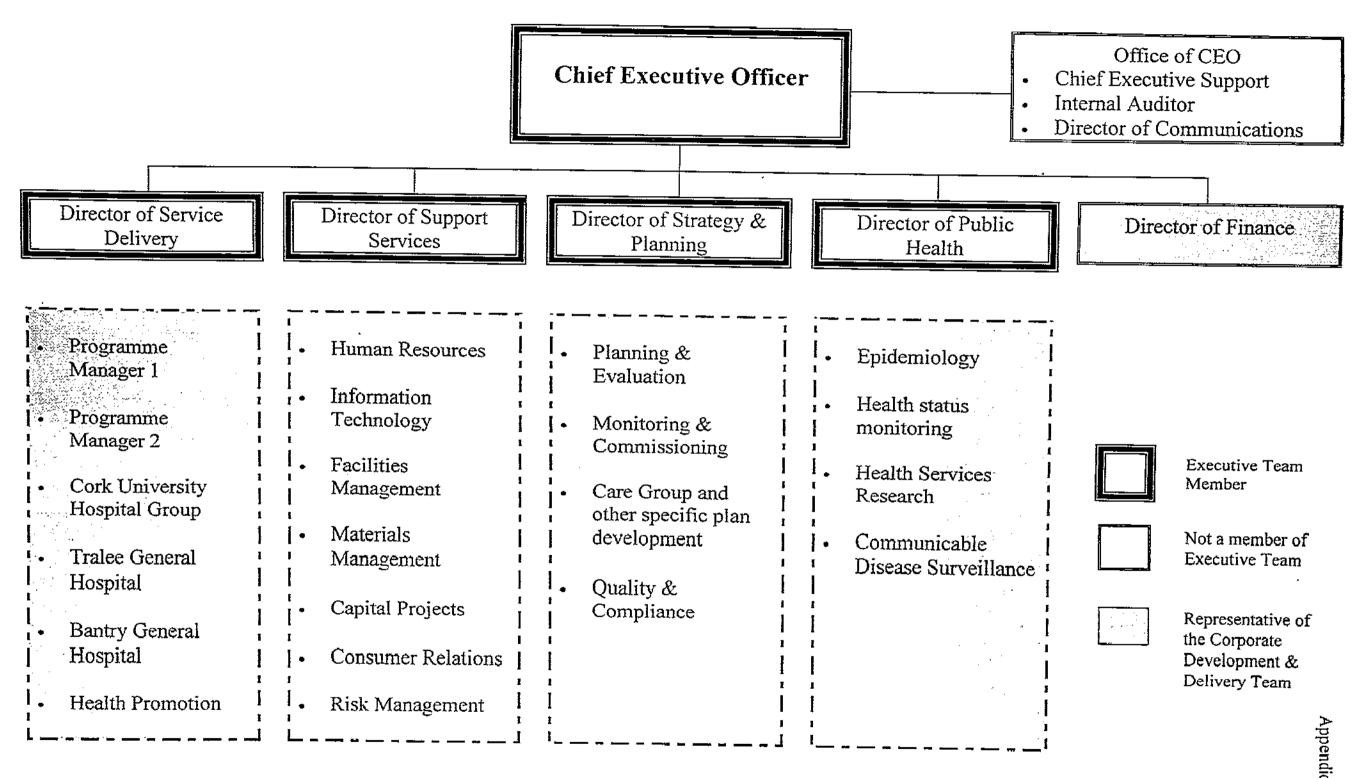
