

## **Aims and Objects**


To help mentally handicapped children and their parents by:

- assessing the degree of disability of these children, and advising on suitable training;
- providing special schools, special care units, training and sheltered workshops, hostels, child development and assessment clinics, etc. where education and treatments can be carried out by fully trained personnel;
- assisting parents of mentally handicapped people by means of lectures, study and by personal advice, to understand and help in training their own children.

## ST. MICHAEL'S HOUSE

What could be more normal — a mother's wish for her child to live at home as part of the family circle, and to have available the educational and other facilities so essential for his normal development. Yet, if the year happened to be 1955 and the child happened to be mentally handicapped, no adequate facilities existed in this country.

The mother of one such mentally handicapped child decided the time was ripe for not only positive thinking, but also for positive action. This resulted in a letter appearing in the national press inviting all interested in helping to provide these essential facilities to attend a public meeting. The meeting was a success, very well attended, and from it a Committee was formed — resulting in the birth of St. Michael's House.

From that small beginning, has grown an organisation which to date consists of fourteen separate units, catering for over 700 mentally handicapped children and young adults, with over three hundred on our waiting lists.

Our child development clinics provide advisory and assessment services, making over 3,000 patient contacts yearly. Our services consist of adult and children's special care units for the severely mentally handicapped, short and long-term training centres, special national schools for moderately mentally handicapped, child development clinics and a group home.

Yet with all that has been achieved through the co-operation of voluntary and statutory agencies, there is still much to be done, with St. Michael's House continuing to play its part in the spirit which led to its foundation.

## **FOREWORD**

The growth of St. Michael's House continues. In Ballymun, a new Child Development and Assessment Clinic and Training Centre, have been opened. In Templeogue, a new adult special care unit has been opened in Cheeverstown House, and a new Group Home at Raheny.

The Association looks after more than seven hundred mentally handicapped persons on a daily basis and through its clinics makes over three thousand patient contacts annually.

The needs of our mentally handicapped call for continued and greater effort. That effort must be directed towards ensuring that, when their disabilities permit it, our handicapped children

and adults remain in the community. This means more group homes, workshops and care units. And so, St. Michael's House calls for the continued help of its dedicated staff, members and friends, to assist in providing the services to which our handicapped are entitled.

On behalf of our Executive Committee, I am pleased to have the opportunity of formally expressing thanks to our staff, friends, benefactors and to the other organisations with whom we have a most satisfactory and constructive relationship in the furtherance of the services for our mentally handicapped citizens.

## ADULT SPECIAL CARE UNITS

With waiting lists continuing to grow, the eagerly awaited move to the adult special care unit (previously sited at Goatstown) to its new home in Cheeverstown House, Templeogue, came about in January, 1975. Cheeverstown, with its beautiful house and gardens, provides an ideal setting for such a group of moderately and severely mentally handicapped young adults.

Belcamp House, our second adult special care unit, has ben continuously adding to its facilities, both in the field of home comforts, equipment and extensions to its existing services in the form of an adolescent group, started in September, 1970. The purpose of this group, consisting of ten young people between the ages of ten and twelve (in charge of a qualified teacher, and her assistant) is to provide a long felt need for a group of young people who were deemed to be too advanced for our children's special care units, and yet too immature for adult special care, as it then existed. The group is proving to be a most worthwhile innovation and one can see it being extended in our programme for the future.





## Short-term training centres

The short-term training centre instructs moderately and mildly mentally handicapped young people from our schools, and those who are presented from various outside sources; namely the National Rehabilitation Board, the various Health Authorities, and other bodies within the community who are also working in the field of mental handicap.

The programme of training is designed to hold what knowledge they have received from school, and add to that knowledge through the educational aspect of the programme, but considering their mental limitations, the emphasis is put on practical work training.







The daily programme is divided into one third educational and social training, the remainder being devoted to practical work training in the form of simple and varied contract work from business houses, thereby simulating the working conditions that are liable to be met within open employment. A full supporting service of medical, psychiatric, para-medical and psychological support is provided during the period of training, usually two years.

One aspect of training which is vital to their future progress is the use of public transport. The staff, with the co-operation and help of parents, have had a very high degree of success, and quite a number of the trainees are even able to cope with two or three changes of buses during their journey to and from the training centre.

## Long-term training centres

The long-term training centres at present consist of two centres (one in the south side, the other sited on the north side of Dublin). The pottery is attached to the south side unit at Goatstown. They have a dual purpose — providing continuous and extended training for some, and a permanent working life for others who are unlikely to be able to cope with open employment.

They are run on business lines under the control of a Manager and supervisory staff.

Long-term training centres play a vital part in the life of all mentally handicapped people, and St. Michael's House hope to play their part in providing more units of this nature in the future.

## Contract work section




Contract work is the life-line of our sheltered workshops. The work is varied, but mostly packing in all its forms, and simple assembly work. It includes collating printed material (many contracts are from Government Departments) packing and carding "handy-packs" — "lucky bags" assembling simple components for electrical trade, etc. The trainees of the long-term centres, and this includes the workers in the pottery, receive a weekly wage.





## **Pottery section**



Working with clay has always given a great deal of satisfaction to the mentally handicapped, both children and adults, but a commercial pottery whose work force are mentally handicapped is a different matter.

The pottery, started in 1971 is a commercial concern forming part of our long-term training centre. It's products are original in design, and manufactured to the required commercial specifications, our only problem to date being lack of space. This we hope will be rectified in the near future. We are understandably proud of our achievements.



## **GROUP HOME**

The original idea behind the Group Home was to provide temporary accommodation for a small number of mentally handicapped who through the development of a crises situation in their homes, (e.g. illness of a parent) required the provision of such a facility.

This type of accommodation also provides a permanent home, after parents die, for those attending long-term training centres where they may continue the normal pattern of living. The group home is a specially designed unit consisting of two semi-detached houses with a bungalow type structure extending from the rear, providing self-contained accommodation for the house parents.



The unit is pleasantly situated facing a small park surrounded by lovely trees, which will in the near future be the site of a church and recreational facilities consisting of tennis and squash courts. The neighbours at Grangemore are mostly young married couples who are both friendly, helpful and most anxious to learn about the problems of mental handicap.

## SPECIAL NATIONAL SCHOOLS

The first day special national school for moderately mentally handicapped was recognised by The Department of Education in 1957, at Northbrook Road.

St. Michael's House now has three special national schools in the Dublin area, and we are building a new school in Raheny.

In all units there is a continual extension to the existing facilities in the form of new classes and aids to development, such as our **Toy Library** which is proving a great success. The particular toy on loan to the child is selected by one of our psychologists who attend during library hours. Apart from the usual special school subjects, educational emphasis is laid on social training, adaptability and the teaching of special skills which will be of use in adult life.



The arts and recreation are not forgotten, and an important part of the curriculum is devoted to classes in art, ballet, music, physical education and home economics.

## CHILD DEVELOPMENT CLINICS

As anticipated, the case load from the north-side of the city increased steadily during 1973-1974. The child development and assessment clinic was housed temporarily in a rented domestic house, proving very satisfactory and acceptable to parents.

With the agreement of the Eastern Health Board and the Daughters of Charity, St. Michael's House now sees cases referred from the north-eastern area of Dublin, as far west as Finglas on the north-side. On the south-side, the work is confined to the assessment of cases presented as suitable for our existing south-side services, and to a small number of paediatric cases.

Co-operation in the zoning of assessment services has been rewarded by the building and furnishing of our very successful new child development and assessment centre, situated at Ballymun, financed by the Eastern Health Board and the Department of Health. Our grateful thanks to both bodies.

This clinic has two play rooms, one of which houses the Toy Library, and one designated garden playroom is equipped with fan, water, plants, budgerigars, wendy house and the invitation to "make a mess". A large fully equipped physiotherapy room and remedial teaching room are now fully in use. The clinic also contains offices for Social Workers; Psychologists; Psychiatrists; Paediatrician, Clinic Secretary and her staff; waiting rooms, cloakrooms and kitchenette-it is already too small.

Staff has increased and there is still a work load sufficient for additional appointments, should finance permit.

The team approach to the mentally handicapped has developed most satisfactorily and our grateful thanks to consultants of other organisations who have generously visited us to discuss, share problems, and help in placements. The provision of day schools for the moderately mentally handicapped, at present inadequate, should be helped by the promised building of a new St. Michael's House school at Raheny in 1976. During 1973 and 1974, provisional classes were still being run at Phibsboro and also for a period at Ballygall Road, with additional classes in the general purposes room at Ballymun School.

An innovation during the period was a successful attempt at parent group

therapy, conducted by our senior psychiatric social worker, to ensure acceptance of the reality of mental handicap. We consider we have failed, if parents are still denying this fact, once the children reach school age, leading to false expectations, fault-finding and unnecessary anxiety.

Many members of staff organised and attended parents meetings, with an accent on early intervention, with organised parent involvement in the extra training and stimulation necessary for the handicapped child. This appears to be of great benefit to the families.

During the latter period, research work was planned and is now to be developed more fully, with funds from the United States of America.

## REMEDIAL CLASSES

Remedial classes are part of the services provided by our Child Development Clinic. Their purpose is to provide means by which young people (between the ages of six to fourteen years) may be helped with their reading problems. This is achieved by group, and where possible individual sessions, under the direction of a qualified remedial teacher.

The original class at Goatstown has been on a full-time basis for the last five years and has been most successful, and a considerable inroad has been made into the extensive waiting list.

The Class in the Ballymun Child Development Clinic (a new building) has not been long in existence but is progressing satisfactorily. It has quite a considerable waiting list due to the numbers awaiting admission in this area. Owing to a Department of education ruling, children may only attend remedial classes after their normal school hours, and understandably many (particularly the younger age group) are tired at this stage. To help this group in particular, in addition to the main emphasis on Reading, additional subjects are included in the session namely, Drama, Painting and Artwork, which help their motor and mental skills as well as increasing their self-confidence and motivation — so many are lacking in these attributes


After a year ( in some cases longer) those attending do progress, gain confidence and are able to continue successfully at school having completed their remedial course.

## SOCIAL OUTLETS

One of the problems of mental handicap is you are in many cases cut off from social outlets normally associated with childhood and young adulthood. Difficulty of communication, lack of consideration and understanding, lack of suitable facilities for recreation — these are only some of the problems that face young people.


We at St. Michael's House have always been very conscious of the lack of facilities, and have endeavoured to try and at least provide some of these needs in the form of clubs held on Saturday afternoons at Grosvenor Road and Ballymun special national schools, mainly for the younger age groups. The adults have their own weekly club held at the short-term training centre, as well as a monthly dance held at the special national school, Ballymun. Other events include outings, summer camps, sports and educational tours.

We know that our present programme, although being added to all the time is inadequate and efforts are being made to develop our facilities as fast as our resources allow.

We are particularly proud of our Grosvenor Road Club which is now nearly twenty years old.







#### SOCIAL CLUBS FOR CHILDREN

Held on Saturday afternoons between 2.30 p.m. — 5.30 p.m. at Grosvenor Road and Ballymun special national schools.

The clubs provide in many cases the only opportunity for young mentally handicapped to meet socially.

The programme includes every kind of playactivity and creative work such as drama, story-telling, arts and crafts and music is encouraged. Membership is open to all handicapped children and their siblings.

#### SOCIAL CLUB FOR ADULTS

The Club is held weekly (except during holiday periods at the short-term training centre, Ballymun between 8.00 p.m. — 9.30 p.m. It provides a means of social contact for the people attending the training centres. The programme consists of hobbies, discussions, sporting activities, i.e. table tennis, etc.

#### MONTHLY DANCE

The dance held at Ballymun special national school on Friday between 8.00 p.m. — 10.45 p.m. is run by a voluntary committee, and has been an outstanding success over the years.

It is an adult social occasion following the accepted pattern of such events, i.e. parents and the older members of the families are encouraged to attend.

#### OUTINGS, SPORTS & HOLIDAY CAMPS

All units within St. Michael's House arrange their own special outings at Christmas and during the summer. They include parties, all-day outings by the sea and visits to places of interest.

Many of the more severely mentally handicapped attend our summer camps — for so many the only holiday they have ever had.

The annual sports held by individual units, and in competition with other organisations in the field of mental handicap, prove to be an enormous success.

The pressures on the Association to extend its services are considerable, and while we have a number of specific projects in mind, the provision of these developments will depend on the availability of finance from voluntary and statutory sources.

Plans are being developed for the extension of our services for adults in the following areas —

- SHELTERED WORKSHOPS
- SPECIAL CARE UNITS
- HOSTELS AND SOCIAL CLUBS

In addition, the need for a Training Centre on the south side of the city is now an urgent necessity. The problem of multiple handicapped children is also being considered and the Association in conjunction with the Department of Education are discussing the provision of a pilot programme to cater for this particular group.

The need for residential care on a short-term basis and on a permanent basis is constantly before our minds, and in conjunction with the Eastern Health Board, and other voluntary organisations, plans are being discussed to meet this need.

The Association is very conscious of the necessity for residential care for many of the cases seen by our Child Assessment teams. The Association is conscious of the standards of care that it has established over the years, and in an attempt to maintain these standards and evaluate the quality of the programmes in its Units, it is initiating a programme of Research. This Research Programme under the direction of the Medical Director, Dr. B. M. Stokes, will commence in 1975. Results will be made available as they arise.

The extent to which the association can develop its services depends on the availability of finance from voluntary and statutory sources, and the Executive Committee is confident that immediate and pressing needs will be met, and that support will be forthcoming from interested people as in the past.
