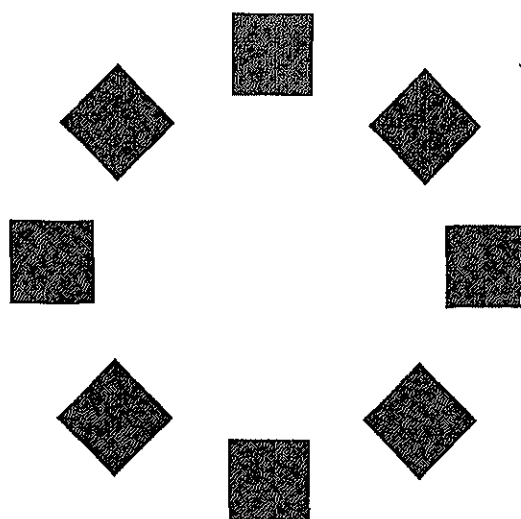

## Ráiteas an Chathaoirligh

Is tréimhse dhúshlánach í seo do na seirbhísí sláinte in Éirinn. Is í an aidhm atá ag obair na Comhairle Náisiúnta ná a chinntiú go mbeidh príomhról ag altraí agus ag cnáimhseacha i múnú seirbhísí sláinte na todhchaí a trí fhorbairt ghairmiúil níos fearr a chur ar fáil dóibh.

D'aithin an Straitéis Sláinte *Ardchaighdeán agus Cothroime – Córas Sláinte Duitse*, na príomhchreatlaigh um athrú laistigh de sheirbhísí sláinte na hÉireann. Pléann Clár Athchóirithe na Seirbhíse Sláinte saincheisteanna a bhaineann leis an gcóras ospidéil géarmhíochaine, le príomhchúram, le sainseirbhísí, le maoiniú don tseirbhís sláinte, le bainistíocht acmhainní daonna, le faisnéis agus ardchaighdeán laistigh de na seirbhísí agus ar deireadh, pléann sé na saincheisteanna casta a bhaineann le hathchóiriú eagrúcháin.

Ina iomlán, is é atá sa chlár athchóirithe seo ná an anailís is cuimsithí a rinneadh riamh ar na seirbhísí sláinte in Éirinn, agus beidh athruithe bunúsacha ar na seirbhísí de bharr na moltaí a tháinig as. Mar sin, tá an clár seo ríthábhachtach agus suntasach do gach duine atá ag obair sna seirbhísí seo, chomh maith le bheith ríthábhachtach do na custaiméirí agus do na cliaint a mbíonn na seirbhísí seo ag freastal orthu.

Beidh impleachtaí ag Clár Athchóirithe na Seirbhíse Sláinte do thodhchaí na Comhairle Náisiúnta, do na seirbhísí a sholáthraíonn sí agus do na feidhmeanna a chomhlíonann sí. Cothófar na príomhfheidhmeanna laistigh d'Fheidhmeannas nua na Seirbhíse Sláinte. Tá an Chomhairle Náisiúnta ag súil leis na hathruithe atá romhainn san altranas agus sa chnáimhseachas a threorú laistigh d'Fheidhmeannas na Seirbhíse Sláinte. Mar sin, cinnteofar go dtabharfar aird ar an gcumas atá ag altranas agus ag cnáimhseachas cur leis na hathruithe sin laistigh den tseirbhís sláinte athchóirithe.

Caithfidh forbairt ghairmiúil an altranais agus an chnáimhseachais a bheith mar chuid lárnach de chlár na n-athruithe, ionas go mbeidh ról iomlán ag an ngairm i gcruthú seirbhíse sláinte a léiríonn na hidéil a cuireadh in iúl sa Straitéis Sláinte. Tá an Chomhairle Náisiúnta iomlán dfograiseach maidir le tacaíocht a thabhairt do na cuspóirí atá ag an gclár athchóirithe, is iad sin, níos mó éifeachtachta, éifeachtúlachta agus comhionannais a bhaint amach; tá sí iomlán dfograiseach maidir le ciudiú leis na hathruithe a éilítear chun na hidéil sin a bhaint amach.





## Chairperson's Statement

These are challenging times in the health services in Ireland. The work of the National Council is aimed at ensuring that, through enhanced professional development, nurses and midwives will play a key role in shaping the health services of the future.

The Health Strategy *Quality and Fairness - A Health System for You* identified the major frameworks for change within the Irish health services. The Health Service Reform Programme addresses issues facing the acute hospital system, primary care, specialised services, health service funding, human resource management, information and quality within the services and, finally, the complex area of organisational reform.

In its totality, this reform programme represents the most comprehensive analysis of the health services ever carried out in Ireland and the recommendations that have emerged are set to change the face of the services fundamentally. This is of great importance and significance to all of us who work within these services and to the customers and clients of these services.

The Health Service Reform Programme has implications for the future of the National Council, the services it provides and the functions it fulfils. The key functions will be maintained within the new Health Service Executive. The National Council looks forward to leading the changes ahead for nursing and midwifery within the Health Service Executive, in order to ensure that the capacity of nursing and midwifery to contribute to this change is realised within a newly reformed health service.

The professional development of nursing and midwifery must remain an integral part of the change programme in order that the profession will play a full role in creating a health service that reflects the ideals articulated in the Health Strategy. The National Council is committed to supporting enthusiastically the reform programme's objectives of greater efficiency, effectiveness and equity, and assisting in the implementation of the changes that will be necessary to achieve those ideals.

De réir Thuarascáil Hanly, "The nursing profession plays a central role in the health system. Nurses are often the first point of contact for patients. They comprise almost 40% of the healthcare workforce and provide care over a 24 hour, 7 day period." Is gné ríthábhachtach den chlár athchóirithe í forbairt ghairmiúil na n-altraí agus na gcnáimhseach laistigh d'Fheidhmeannas na Seirbhíse Sláinte a chothabháil agus a láidriú. Caithfear uchtach a thabhairt d'altraí agus do chnámhseacha cur leis an bpróiseas athchóirithe, chomh maith le dul i gcion air, ag gach céim iomchuí. Bíonn a gcuid inniúlachtaí agus a gcuid saineolais ríthábhachtach le héifeachtúlacht na seirbhísí, agus seachadadh na seirbhísí sin don phobal, a chinntiú.

Ó bunaíodh í, tá iarrachtaí déanta ag an gComhairle Náisiúnta teorainneacha na ngairmeacha altranaís agus cnáimhseachais a fhorbairt agus a mhéadú. Fuarthas spreagadh ón gcuspóir atá aici an fhís den altranas agus den chnámhseachas atá ar fáil i dTuarascáil Deiridh an Choimisiúin Altranaís a chur chun cinn, agus ag an mian atá aici aghaidh a thabhairt ar riachtanais na seirbhíse agus na gairme.

Tá treoir tugtha ag an gComhairle Náisiúnta i réimsí a bhaineann le forbairt ghairmiúil, oideachas leanúnach, forbairt conairí gairme agus taighde. Ina theannta sin, scaip sí faisnéis iomchuí faoin altranas agus faoin gcnáimhseachas i slí a bhí iomlán nua d'Éirinn. Tá dul chun cinn maith déanta ag an gComhairle Náisiúnta maidir le méid criticiúil faisnéise agus gníomhaíochta forbartha gairmiúla a chruthú. D'fhéadfadh na rudaí sin difríocht shuntasach a dhéanamh don bhaint a bhíonn ag altraí agus ag cnáimhseacha le seachadadh seirbhísí sláinte in Éirinn.

Thar ceann na Comhairle Náisiúnta, teastaíonn uaim fforbhuíochas a ghlacadh leis an Aire Sláinte agus Leanaí, an tUasal Micheál Martin TD; leis An Rannán um Beartas Altranaís sa Roinn Sláinte agus Leanaí; agus leis na comhlachtaí gairmiúla agus ionadaíochta náisiúnta, réigiúnacha agus áitiúla a thug lántacaíocht don Chomhairle Náisiúnta agus í ag iarraidh tuilleadh forbartha a dhéanamh ar altranas agus ar chnámhseachas in Éirinn.

Ba mhian liom freisin mo bhuíochas a ghlacadh le mo chomhghleacaithe ar an gComhairle Náisiúnta agus lenár bhfoireann feidhmiúcháin, as an díograis iontach a léirigh siad le dhá mhí dhéag anuas. 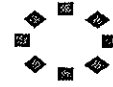

## Tuarascáil an Phríomhfheidhmeannaigh

I 2003, chríochnaigh an Chomhairle Náisiúnta a ceathrú bliain d'oiríochtaí. Is tréimhse ghairid í seo, ach fós féin tá dul chun cinn suntasach déanta ag an gComhairle Náisiúnta i gcothú an chláir oibre a d'aithin an Coimisiún Altranais. Is iad seo a leanas na torthaí atá bainte amach ag an gComhairle go dtí seo.

- Dearadh agus cuireadh i bhfeidhm conair ghairme chliniciúil shoiléir don altranais agus don chnámhseachas a théann leis na moltaí a rinne an Coimisiún Altranais.
- Tá an conair idirmheánach le haghaidh ceadú speisialtóirí altranais/cnámhseachais cliniciúla fós á chur i bhfeidhm tríd an tír iomlán.
- Tá an borradh atá ag teacht ar líon na speisialtóirí altranais/cnámhseachais cliniciúla ceadaithe in Éirínn de réir riachtanais na seirbhíse agus na forbartha atá ag teacht ar dheiseanna d'fhorbairt ghairmiúil. Go dtí seo, ceadaíodh 1,484 speisialtóirí altranais/cnámhseachais cliniciúla.
- Tá an borradh atá ag teacht ar líon na n-ardchleachtóirí altranais/cnámhseachais creidiúnaithe atá sa tír de réir riachtanais na seirbhíse agus soláthar cláir oideachais iomchuí. Go dtí seo, ceadaíodh seisear dóibh.
- Forbraíodh treoiríní soiléire do chláir oideachais atá dírithe ar speisialtóirí altranais/cnámhseachais agus ar ardchleachtóirí altranais/cnámhseachais. Pléadh iad siúd le soláthraithe seirbhíse agus le forais tríú leibhéal.
- Tionóltar sé chruinniú dhéag sa bhliain agus bíonn na stiúrthóirí altranais/cnámhseachais uile as gach réigiún atá i gcomhpháirtíocht leis na haonaid phleanála agus forbartha altranais agus cnámhseachais i láthair.
- Cuireann gach aonad phleanála agus forbartha altranais agus cnámhseachais pleananna nua chun maoinithe tionscnamh oideachais leanúnaigh bhreise faoi bhráid na Comhairle. Bíonn baint ag líon mór indeimhnithe altraí agus cnámhseacha leis na tionscnaimh sin ar fud na tíre gach bliain. Go dtí seo, d'fhreastal níos mó ná 10,000 altra agus cnámhseach ar chláir oideachais leanúnaigh a bhí maoinithe ag an gComhairle Náisiúnta.
- Tá tuarascáil mhionsonraithe ar na gníomhaíochtaí taighde atá ar siúl ar fud na tíre faoi láthair á hullmhú. Tá bunachair shonraí á bhforbairt le súil a choinneáil ar na tionscnaimh thaighde go léir.
- Forbraíodh clár chun taighde breise a chur chun cinn agus cuireadh i bhfeidhm é.



## Chief Executive Officer's Report

In 2003, the National Council completed its fourth year of operations. In this comparatively short period of time, the National Council has made significant progress in progressing the agenda identified by the Commission on Nursing. The achievements of the National Council to date include the following:

- A clear clinical career pathway for nursing and midwifery has been designed and implemented in line with the recommendations of the Commission on Nursing.
- The intermediate pathway for the approval of clinical nurse/midwife specialists continues to be implemented throughout the country.
- The number of approved clinical nurse/midwife specialists in the country continues to grow in line with service needs and developing professional development opportunities. To date, 1,484 clinical nurse/midwife specialists have been approved.
- The numbers of accredited advanced nurse/midwife practitioners in the country continues to grow in line with service need and provision of appropriate educational programmes. To date, six have been approved.
- Clear guidelines have been developed for educational programmes for clinical nurse/midwife specialists and for advanced nurse/midwife practitioners. These have been negotiated with service providers and third-level institutions.
- Sixteen meetings per year are held with all directors of nursing/midwifery in each of the regions in partnership with the nursing and midwifery planning and development units.
- Each nursing and midwifery planning and development unit submits new plans for funding for additional continuing education initiatives involving a substantial and verifiable number of nurses and midwives throughout the country each year. To date over 10,000 nurses and midwives have attended continuing education programmes funded by the National Council.
- A detailed report on research activities currently in place throughout the country is in production. Databases are being developed to track all research initiatives.
- A programme to promote additional research has been developed and implemented.



- Tá an Tionscadal *Review of Nurses and Midwives in the Prescribing and Administration of Medical Products* atá á reáchtáil ag an gComhairle Náisiúnta i gcomhar leis an mBord Altranais fós ag dul chun cinn.
- Tugann comhdháil bhliantúil na Comhairle Náisiúnta deis do thart ar 1,000 altra agus cnáimhseach éisteacht le speisialtóirí ceannasacha, agus bíonn seans acu freisin ceisteanna a mbaineann ríthábhacht leo ó thaobh fhorbairt na gairme agus na seirbhísí a phlé.
- Bíonn cruinnithe rialta eagraithe le hionadaithe na gcoláistí tríd leibhéal agus tugtar cuireadh dóibh freisin freastal ar sheimineáir réigiúnacha na Comhairle Náisiúnta.
- Chruthaigh an Chomhairle Náisiúnta láithreán greasáin dílis le haghaidh na gairme, agus is acmhainn thábhachtach é sin anois le haghaidh altraí agus cnáimhseach. Aimsíodh an láithreán greasáin os cionn leathmhíliúin uair do dtí seo.
- Foilsíonn an Chomhairle Náisiúnta nuachtlitrí gach ráithe ina mbíonn ailt agus faisnéis a mbaineann tábhacht leo. Bíonn gnáthscaipeadh thart ar 60,000 ag gach eagrán agus scaiptear é chuig gach altra agus cnáimhseach atá ar an gclár comhaltaí.

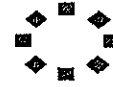
Mar achoimre, tá an Chomhairle Náisiúnta tar éis dul chun cinn a dhéanamh ar a lán de na saincheisteanna tábhachtacha maidir le forbairt ghairmiúil a d'aithin an Coimisiún Altranais agus atá le sárú ag altraí agus cnáimhseacha. Mar sin féin, níl an fhís fhadtréimhseach agus na straitéisí fadtréimhseacha a bhaineann le mórán de na saincheisteanna sin curtha i gcrích fós.

Faoi Chlár Athchóirithe na Seirbhíse Sláinte, leanfar ar aghaidh le feidhmeanna na Comhairle Náisiúnta laistigh d'Fheidhmeannas nua na Seirbhíse Sláinte. Is léir go n-aithníonn próiseas an athraithe an méid atá bainte amach go dtí seo, agus go gcuireann sé leis. Tá sé tábhachtach a chinntiú go leanfar ar aghaidh le cur chun cinn béime leithne físe an Choimisiúin Altranais.

I 2003, d'fhoilsigh an Chomhairle Náisiúnta *The Agenda for the Future Professional Development of Nursing and Midwifery*, cápeis ina raibh torthaí an phróisis fhairsing taighde agus chomhairliúcháin a bhí ar siúl sa bhliain roimhe sin. Bhain an próiseas sin le níos mó ná ocht gcéad altra agus cnáimhseach, le dhá cheardlann is fiche, agus le cruinnithe breise leis na príomhpháirtithe leasmhara ó cheantair ar fud na tíre. Aithníonn an cháipéis Agenda na príomh-shaincheisteanna forbartha a bheidh i gceist don altranais agus don chnáimhseachas amach anseo, agus cuireann sí ardán ar fáil trín ar féidir freagraí straitéiseacha ar na saincheisteanna a chruthú.

Is iad seo a leanas na heilimintí substainteacha i gclár oibre na Comhairle Náisiúnta:

- Caitear taighde leanúnach a bheith mar bhunús le cleachtais altranais agus chnáimhseachais. Is saincheist sheirbhíse í sin agus tá nasc soiléir idir an taighde a dhéantar agus cúram ar ardchaighdeán agus roghanna a thabhairt d'othair.



- The *Review of Nurses and Midwives in the Prescribing and Administration of Medical Products* Project, run jointly by the National Council and An Bord Altranais, continues to advance.
- The National Council's annual conference provides an opportunity for approximately 1,000 nurses and midwives to hear leading specialists and discuss issues of central importance to the development of the profession and of the services.
- Regular meetings are held with representatives of the third-level colleges, who are also invited to participate in the National Council's regional seminars.
- The National Council has developed a dedicated website for the profession, which is now an important resource to nurses and midwives. To date over half a million hits have been recorded.
- The National Council publishes a quarterly newsletter, containing articles and information of value. It has an average circulation per issue of approximately 60,000 and is distributed to all nurses and midwives on the register.

In summary, the National Council has progressed many of the important professional development issues facing nurses and midwives that were identified by the Commission on Nursing. However, the long-term vision and strategies for many of these issues have yet to be realised.

Under the Health Service Reform Programme, the functions of the National Council will continue within the new Health Service Executive. Clearly, the change process recognises and builds on what has been achieved to date. It is important to ensure that the broad thrust of the vision of the Commission on Nursing should continue to be moved forward.

In 2003, the National Council published *The Agenda for the Future Professional Development of Nursing and Midwifery*. This contained the results of an extensive research and consultation process that had taken place over the previous twelve months, involving over eight hundred nurses and midwives, twenty-two workshops and additional meetings with key stakeholders from all over the country. The Agenda document identifies the key development issues facing nursing and midwifery in the future and provides a platform for formulating strategic responses to these issues.

The following are substantive elements in the National Council's agenda:

- Nursing and midwifery practice needs to be underpinned by research on an ongoing basis. This is a service issue and is clearly linked with quality of care and choice for patients.

- Tá méadú i gcónaí ag teacht ar chúrsaí iarchlárúcháin a mbaineann faid, ábhair agus gradaim acadúla éagsúla leo. Bíonn gá ann i gcónaí le treoir d'altraí agus do chnáimhseacha nuair a bhíonn cláir iarchlárúcháin á roghnú acu.
- Taobh amuigh de chreidiúnú na gcúrsaí, tá gá le ról láidir leanúnach i bhforbairt na gcúrsaí sin chun dul i ngleic le riachtanas/forbairt seirbhíse ar bhealach éifeachtach ó thaobh costais, ceangailte le buiséad oideachais leanúnaigh. Chun é seo a chur i gcrích tá sé tábhachtach go mbíonn comhoibriú leanúnach ar siúl leis na haonaid phleanála agus forbartha altranais agus cnáimhseachais, le coláistí tríú leibhéal agus leis na hionaid oideachais altranais. Tá bealach fada le dul fós ag an gcineál seo oibre agus tá gá le feidhmiú agus forbairt leanúnach.
- Agus an treo ina rachaidh oideachas iarchlárúcháin altranais sa todhchaí á mheas aige, thuig an Coimisiún Altranais go gcaithfí, ag an am céanna, creatlach comhtháite a fhorbairt d'oideoirí altraí atá páirteach faoi láthair i múineadh cláir iarchlárúcháin; ina measc siúd tá teagascóirí altranais, comhordaitheoirí cúrsaí agus éascaitheoirí cúrsaí. Mhol an Coimisiún go gcruthófaí comhcheapacháin chliniciúla agus acadúla chun go mbunófaí naisc láidre idir teoiric agus cleachtas cliniciúil speisialtóra.
- Leag *The Agenda for the Future Professional Development of Nursing and Midwifery* béim ar rólanna nua cosúil le ról na n-éascaitheoirí scileanna cliniciúla a fhorbairt taobh le rólanna níos gnásúla, agus leag sé béim freisin ar an ngá atá ann na rólanna sin a athbhreithniú ag leibhéal náisiúnta. Ina theannta sin leag an doiciméad Agenda béim ar an ngá atá ann tacú leis an altra ginearálaithe chomh fada agus a bhaineann sé le hinniúlachtaí cleachtais, forbairt gairme, earcaíocht agus coinneáil foirne. Tá gá ann monatóireacht a dhéanamh ar níos mó ná na gnáthchonaí gairme cliniciúla.
- Is díol imní é an baol foláigh a bhaineann le hilroinnt mhéadaithe i seirbhís an altranais agus an chnáimhseachais de bharr na forbartha tapa atá tagtha ar altranais agus ar chnáimhseachas agus de bharr méadú a bheith tagtha ar na deiseanna d'altraí agus do chnáimhseacha díriú ar ábhair faoi leith agus speisialtóireacht a dhéanamh ina gcuid cleachtais. Tá gá le pleanáil éifeachtach a dhéanamh ar an acmhainn altranais agus chnáimhseachais, go háirithe chun na riachtanais oideachasúla agus na scileanna altranais agus cnáimhseachais a aithint a mbíonn gá leo chun freastal ar riachtanais na seirbhíse sláinte.

Táimid ag tnúth go mór le leanúint orainn ag baint amach ár spriocanna lenár gcomhghleacaithe gairmiúla san altranais agus sa chnáimhseachas sna blianta atá amach romhainn.

- There remains a proliferation of post-registration courses of varying length, content and academic award and there continues to be a need for guidance for nurses and midwives when selecting post-registration programmes.
- As distinct from the accreditation of courses, there is a need for a continued strong role in the development of courses to match service need/development in a cost-efficient manner linked with continuing education budget. This requires ongoing collaboration with the nursing and midwifery planning and development units, third-level colleges and the centres of nurse education. This area of work is at a very early stage and needs continued facilitation and development.
- The Commission on Nursing, in considering the future direction of post-registration nursing education, was conscious of the need to develop simultaneously a coherent framework for the nurse educators currently involved in the delivery of post-registration programmes; these include nurse tutors, course co-ordinators and course facilitators. The Commission recommended the creation of joint clinical academic appointments to establish strong links between theory and specialist clinical practice.
- The *Agenda for the Future Professional Development of Nursing and Midwifery* highlighted new roles such as clinical skills facilitator developing alongside more conventional roles and the need to review these at national level. The Agenda document also highlighted the need to support the generalist nurse in terms of competencies for practice, career development, staff recruitment and retention. There is a need to monitor more than the conventional clinical career pathways.
- The rapid development of nursing and midwifery and the increasing opportunities for nurses and midwives to focus and specialise in their practice raise concerns about the potential for increased fragmentation of the nursing and midwifery service. Effective planning of the nursing and midwifery resource is required, particularly in identifying the educational and skills requirement of nursing and midwifery to match health service need.

We look forward to continuing to work with our professional colleagues in nursing and midwifery for many years to come in achieving our goals.

## Ról agus Feidhmeanna na Comhairle Náisiúnta

Bunaíodh an Chomhairle Náisiúnta i mí na Samhna 1999 de thoradh ar Ionstraim Reachtúil (IR Uimh. 376, 30 Samhain 1999) ar a dtugtar *an tOrdú fán gComhairle Náisiúnta d'Fhorbairt Ghairmiúil an Altranais agus an Chnáimhseachais (Bunú), 1999*. Thug an tAire Sláinte agus Leanaí an Ionstraim Reachtúil isteach.

Mar atá luaite san Ionstraim Reachtúil (Alt 4), is iad na feidhmeanna atá ag an gComhairle Náisiúnta ná:

- a. Monatóireacht a dhéanamh ar an bhforbairt leanúnach ar speisialtachtaí altranais agus cnáimhseachais, ag cur san áireamh athruithe i gcleachtas agus riachtanais seirbhíse;
- b. Treoirínte a chur le chéile chun cabhair a thabhairt do bhoird sláinte agus do chomhlachtaí chomhlachtaí iomchuí eile poist speisialtachta altranais agus cnáimhseachais a chruthú;
- c. Tacaíocht a thabhairt d'fhorbairtí eile in oideachas leanúnach altranais atá á ndéanamh ag na boird sláinte agus eagraíochtaí deonacha;
- d. Cabhrú le soláthraithe seirbhísí sláinte trí threoirínte a leagan amach dóibh faoi roghnú na n-altraí agus na gcnáimhseacha ar féidir leo cur isteach ar thacaíocht airgeadais agus iad ag lorg deiseanna chun breis oideachas a fháil;
- e. Tuarascáil bhliantúil a fhoilsiú i dtaobh na ngníomhaíochtaí a mbíonn baint ag an gComhairle leo, an díscaoileadh airgid a dhéanann sí san áireamh.

Tugann na feidhmeanna seo léargas ar chúig cinn dóibh siúd a mhol an Coimisiún Altranais (alt 6.14)<sup>1</sup>.

## The Role and Functions of the National Council

The National Council was established in November 1999 on foot of a Statutory Instrument (SI No 376, 30 November 1999) from the Minister for Health and Children and entitled *The National Council for the Professional Development of Nursing and Midwifery (Establishment) Order, 1999*.

As stated in the Statutory Instrument (Section 4), the functions of the National Council are:

- a. To monitor the on-going development of nursing and midwifery specialities, taking into account changes in practice and service need;
- b. To formulate guidelines for the assistance of health boards and other relevant bodies in the creation of specialist nursing and midwifery posts;
- c. To support additional developments in continuing nurse education by health boards and voluntary organisations;
- d. To assist health service providers by setting guidelines for the selection of nurses and midwives who might apply for financial support in seeking opportunities to pursue further education;
- e. To publish an annual report on its activities, including the disbursement of monies by the Council.

These functions reflect five of those recommended by the Commission on Nursing (par 6.14)<sup>1</sup>.

## Clár Athchóiriúcháin na Seirbhíse Sláinte

I mí an Mheithimh 2003 sheol an Rialtas Clár Athchóirithe na Seirbhíse Sláinte mar chuid lárnach de chur i bhfeidhm na Straitéise Sláinte dár teideal *Ardchaighdeán agus Cothroime – Córas Sláinte Duitse* (2001). Mar chuid den phróiseas comhchomhairle a bhaineann leis an gClár Athchóirithe, ar an 30 Meán Fómhair 2003 rinne an Chomhairle Náisiúnta aighneacht chuig an Oifig Tionscadail a bhí freagrach as an gclár a chur i bhfeidhm. Dhírigh an aighneacht seo, go háirithe, ar na conclúidí agus moltaí atá le fáil sa cháipéis *Audit of Structures and Functions in the Health System (Prospectus Report, Meitheamh 2003)*. Cuimsíodh na nithe seo a leanas san aighneacht:

- Anailís ar shaincheistanna altranais agus cnáimhseachais a bhaineann leis an gClár Athchóirithe
- Cúlra bhunú na Comhairle Náisiúnta agus na spriocanna atá bainte amach aici
- Na himpleachtaí a bhaineann le príomhfheidhmeanna na Comhairle Náisiúnta a chur san áireamh i bhFeidhmeannas na Seirbhíse Sláinte atá molta sa *Prospectus Report*. Clár Athchóirithe na Seirbhíse Sláinte



## Health Service Reform Programme

In June 2003 the Government launched the Health Service Reform Programme as an integral part of the implementation of the Health Strategy, *Quality and Fairness – A Health System for You* (2001). As part of the consultation process associated with the Reform Programme, the National Council made a submission to the Project Office responsible for the implementation of the programme on 30 September 2003. This submission concentrated in particular on the conclusions and recommendations contained in the *Audit of Structures and Functions in the Health System* (*Prospectus Report*, June 2003). The submission included the following:

- An analysis of nursing and midwifery issues relating to the Reform Programme
- The background to the establishment of the National Council and its achievements
- The implications of incorporating key functions of the National Council into the Health Service Executive as proposed within the *Prospectus Report*.

# Activities Report

## An Bealach Chun Cinn

Cuireadh le chéile dhá phríomhdhoiciméid i 2003; *Agenda for the Future Development of Nursing and Midwifery* agus *Guidelines for Portfolio Development for Nurses and Midwives*, a léirigh na rudaí ar cheart d'altraí agus do chnámhseacha a chur san áireamh agus iad i mbun bealaí a fháil chun gluaiseacht chun cinn mar dhaoine aonair agus mar ghrúpa gairmiúil.

### An Clár Oibre d'Fhorbairt Ghairmiúil an Altranais agus an Chnámhseachais

I ndiaidh comhchomhairle cuimsithí leis na gairmeacha altranais agus cnámhseachais in Éirinn, agus tar éis litríocht idirnáisiúnta a athbhreithniú, foilsíodh doiciméad de chuid na Comhairle Náisiúnta i mBealtaine 2003, ar a dtugtar *Agenda for the Future Development of Nursing and Midwifery*, le ceadú ó chomhaltaí na Comhairle Náisiúnta.

Is slat tomhais é an doiciméad seo a thaispeánann an dul chun cinn atá déanta san altranais agus sa chnámhseachas ón uair a foilsíodh *Tuarascáil an Choimisiúin Altranais: A Blueprint for the Future* (1998). Leagann an doiciméad nua clár oibre amach le díospóireacht a dhéanamh ar roghanna, ar threoracha agus ar ghníomhartha don todhchaí i gcomhthéacs na Straitéise Sláinte reatha, *Ardchaighdeán agus Cothroime – Córas Sláinte Duitse* (2001) agus i gcomhthéacs Chlár Athchóirithe na Seirbhíse Sláinte (2003).

### Treoirínte d'Fhorbairt Punainne d'Altraí agus do Chnámhseacha

Tar éis ceadú a fháil ó chomhaltaí na Comhairle Náisiúnta i Meán Fómhair 2003, foilsíodh *Guidelines for Portfolio Development for Nurses and Midwives* i bhfoirm doiciméide agus dlúthdhiosca léimh amháin CD-ROM agus seoladh é ag an tréimh comhdháil náisiúnta i mí na Samhna. Tá na treoirínte seo dírithe go háirithe ar altraí agus ar chnámhseacha aonair a bhíonn ag obair go praiticiúil agus go laethúil sa chóras sláinte. Is é an cuspóir atá ag na treoirínte seo ná cabhrú le haltraí agus le cnámhseacha an chomaoin a chuireann siad ar an chúram díreach agus indíreach a aithint, a mheas agus a thaifeadadh, iad a spreagadh le taifid ar a gcuid forbairtí a stóráil go comhleanúnach agus go déanmhasach, agus treoir agus faisnéis a chur ar fáil dóibh faoi conas ar féidir leo a spriocanna gairmiúla aonair a bhaint amach i gcomhthéacs riachtanais na seirbhíse sláinte.

Scaipeadh *Agenda for the Future Development of Nursing and Midwifery* agus *Guidelines for Portfolio Development for Nurses and Midwives* go forleathan i measc príomhphearsanra agus páirtithe leasmhara agus bhí sé ar fáil ar an láithreán gréasáin chomh maith. Foilsíodh leaganacha achoimrithe d'fobh sna heisiúintí a cuireadh amach sa Samhradh agus sa Gheimhreadh faoi seach.



## The Way Ahead

In 2003 two key documents, *Agenda for the Future Professional Development of Nursing and Midwifery* and *Guidelines for Portfolio Development for Nurses and Midwives*, were produced that indicated what nurses and midwives should take into consideration when identifying ways of moving forward both as individuals and collectively as a professional group.

### Agenda for the Future Professional Development of Nursing and Midwifery

After extensive consultation with the nursing and midwifery professions in Ireland and a review of international literature, the National Council's document *Agenda for the Future Development of Nursing and Midwifery* was approved for publication by National Council members in May 2003.

This document provides a benchmark for progress made in nursing and midwifery since the publication of the *Report of the Commission on Nursing: A Blueprint for the Future* (1998) and sets an agenda for debate on options, direction and action for the future in the context of the current Health Strategy, *Quality and Fairness – A Health System for You* (Department of Health & Children, 2001), and the Health Service Reform Programme (2003).

### Guidelines for Portfolio Development for Nurses and Midwives

Following approval by National Council members in September 2003, the *Guidelines for Portfolio Development for Nurses and Midwives* were published in document and CD-ROM formats and launched at the third national conference in November. These guidelines are aimed particularly at individual nurses and midwives working at the forefront of healthcare delivery, for the purpose of assisting them to identify, reflect upon and record the contribution they make to direct and indirect care, encouraging them to store records of their development in a coherent and structured manner, and providing guidance and information on achieving their individual professional goals within the context of the needs of the health service.

*Agenda for the Future Development of Nursing and Midwifery* and *Guidelines for Portfolio Development for Nurses and Midwives* were distributed widely among key personnel and stakeholders and made available on the website. Summarised versions were included in the summer and winter issues of the newsletter respectively.

## Postanna do Speisialtóirí Altranais/Cnáimhseachais Cliniciúla

Lean feidhmeannas na Comhairle Náisiúnta ar aghaidh ag déanamh monatóireachta ar phoist speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS), i gcomhpháirtíocht leis na haonaid phleanála agus forbartha altranais agus cnáimhseachais (NMPDU).

Chuathas i mbun tuilleadh forbartha a dhéanamh ar bhunachar sonraí na speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS), chun go mbeadh sé níos éasca sonraí a iontráil agus tuairiscí a thiomnú, agus leanfar leis an bhforbairt seo 2004. Déantar staitisticí i dtaobh dáilte réigiúnaigh na bpost le haghaidh speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS) atá ceadaithe agus an rannán cuí den chlár comhaltaí a fhoilsiú ar láithreán gréasáin na Comhairle Náisiúnta agus déantar é a nuashonrú gach mí. Tá na figiúirí de na poist speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS) atá ceadaithe i ngach réigiún boird sláinte agus i ngach rannán cleachtais den chlár comhaltaí le feiceáil i dTábla 1 thíos.

Forbraíodh treoiríníte dóibh siúd a bhí ag iarraidh faisnéise faoi phost ceadaithe speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS) le haghaidh taighde, agus scaipeadh na treoiríníte ar iarratas i 2003.

## Clinical Nurse Specialist/Clinical Midwife Specialist Posts

The executive of the National Council continued to monitor clinical nurse and midwife specialist (CNS/CMS) posts, in partnership with the nursing and midwifery planning and development units (NMPDUs).

Further development of the CNS/CMS database was undertaken, in order to facilitate the entry of data and the production of reports, and will continue in 2004. Statistics on the regional distribution of approved CNS/CMS posts and the relevant division of the register are published on the National Council's website and updated monthly. Figures for the approved CNS/CMS posts in each health board region and practising division of the register are shown below in Table 1.

Guidelines were developed for those requiring information on approved CNS/CMS posts for research purposes and circulated on request in 2003.

## Tionscadal do Speisialtóirí Altranais/Cnáimhseachais Cliniciúla: Measúnú ar Éifeachtúlacht Ról an Speisialtóra Altranais/Cnáimhseachais Chliniciúil in Éirinn

Thug an Chomhairle Náisiúnta faoi thionscadal náisiúnta taighde chun éifeachtúlacht ról an speisialtóra altranais agus cnáimhseachais chliniciúil (CNS/CMS) in Éirinn a mheas. Baineadh úsáid as modheolaíochtaí eagsúla agus rinneadh athbhreithniú ar litríocht chuif, idir idirnáisiúnta agus Éireannach. Cuireadh fócasghrúpaí ar bun i ngach bord sláinte agus tugadh cuireadh do rannpháirtithe arb ionadaithe iad do stiúrthóirí altranais/cnáimhseachais, lárbhainisteoirí altranais/cnáimhseachais, speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS), altraí/cnáimhseacha foirne agus othair/cliainnt a bheith i lárthair (n=274). Rinneadh anailís ar shonraí ag úsáid cur chuige bunaithe ar anailís ábhair. Seoladh ceistiúchán chuig gach speisialtóir altranais agus cnáimhseachais chliniciúil (CNS/CMS) ceadaithe (n=1372). Bhí an ceistiúchán bunaithe ar staidéar de chuid Bamford agus Gibson (2000)<sup>2</sup> faoi na tuairimí a bhí ag speisialtóirí altranais cliniciúla (CNS) a bhíonn ag cleachtadh i dtaobh an róil atá acu agus faoina riachtanais forbartha.

I measc na dtéamaí a tháinig aníos san anailís ábhair bhí ullmhúchán don ról, rathúlacht an róil, luach an róil d'altraí/cnáimhseacha foirne agus d'othair/cliainnt, gnéithe oideachasúla an róil agus an gá atá le forbairt ghairmiúil leanúnach sa réimse a bhaineann le torthaí iniúchta agus feidhmíthe a thomhais. Tá sé tagtha chun solais go maireann ról an speisialtóra altranais agus cnáimhseachais chliniciúil (CNS/CMS) ar chontanam forbartha. Cé go bhfuil imní ar chuid de na speisialtóirí altranais agus cnáimhseachais cliniciúla (CNS/CMS) faoin nglacadh a bheidh ag altraí/cnáimhseacha eile agus ag gairmithe sa tseirbhís sláinte leis an ról seo, faoi lánpháirtíú agus faoi easpa acmhainní, tá cuid acu ag tomhais éifeachtaí a gcuid idirghabhálacha agus ag iniúchadh a gcuid oibre cheana féin. Foilseofar an tuairisc seo ag tús 2004.

## Clinical Nurse Specialist/Clinical Midwife Specialist Project: An Evaluation of the Effectiveness of the Role of the Clinical Nurse/Midwife Specialist in Ireland

The National Council undertook a national research project to evaluate the effectiveness of the role of the CNS/CMS in Ireland. A mixed methodology was adopted, and a review of the relevant international and Irish literature was undertaken. Focus groups were held in each health board and participants representative of directors of nursing/midwifery, middle nurse/midwifery managers, CNSs/CMSs, staff nurses/midwives and patients/clients were invited to participate (n=274).

Data was analysed using a content analysis approach. All approved CNSs/CMSs (n=1372) were sent a questionnaire which was based on Bamford and Gibson's (2000)<sup>2</sup> study of the perceptions of practising CNSs of their role and development needs.

Themes arising from the content analysis included role preparation, success of the role, the value of the role to staff nurses/midwives and patients/clients, the educational aspects of the role, the need for continuing professional development in the area of audit and performance measurement outcomes. It has emerged that the role of the CNS/CMS exists on a developmental continuum. While some CNSs/CMSs have concerns about acceptance of the role by other nurses/midwives and healthcare professionals, integration and lack of adequate resources, others are already measuring the effects of their interventions and auditing their work. The report will be published in early 2004.

## Advanced Nurse Practitioner/ Advanced Midwife Practitioner Posts

Two advanced nurse practitioner (ANP) posts were approved and two ANPs were accredited in 2003, bringing the total number of ANP posts and post-holders to six. These are:

- Four ANP posts in emergency nursing at St James's Hospital, Dublin
- One ANP post in sexual health nursing at St James's Hospital, Dublin
- One ANP post in rheumatological nursing at Our Lady's Hospice, Dublin

A number of ANP applications are in progress at the end of 2003.

## Aonaid Phleanála & Forbartha Altranais agus Cnáimhseachais

Lean an Chomhairle Náisiúnta ar aghaidh le cruinnithe a reáchtáil go rialta i rith na bliana le stiúrthóirí na n-aonad pleanála agus forbartha altranais agus cnáimhseachas (NMPDU). Ba é an clár oibre a bhí ann do na cruinnithe sin ná príomhcheisteanna a bhain le forbairt straitéiseach. I measc na n-ábhar a bhí ann do 2003 bhí an fhorbairt ar phoist speisialtóirí altranais agus cnáimhseachais cliniciúla(CNS/CMS) agus poist d'ardchleachtóirí altranais agus cnáimhseachais (ANP/AMP), forbairt ar rólanna ginearálaithe, ar thaighde, ar chúram an duine aosta i réimsí éagsúla agus athchóiriú ar an seirbhís sláinte.

Déanadh dul chun cinn ar an gclár oibre seo mar gheall ar an ngaolmhaireacht éifeachtach oibre a bhí idir foirne na Comhairle Náisiúnta agus na haonaid phleanála agus forbartha altranais agus cnáimhseachais. Déanadh an bunobair ar fad sna cruinnithe a bhí acu go rialta agus trí theagmháil fhoirmiúil agus neamhfoirmiúil maidir lena lán saincheisteanna gairmiúla agus nósanna imeachta.

Cuireadh formáid nua i bhfeidhm do na cruinnithe réigiúnacha i bhFómhar na bliana 2003, agus foirmíodh grúpaí níos lú agus tugadh an deis dóibh an clár oibre a bhain le cúram an duine aosta a phlé ag leibhéal réigiúnach. Chinntigh an cur chuige seo go raibh cumarsáid idirdhisciplíneach níos fearr agus mar thoradh air sin bhí níos mó aird á thabhairt ar dhearcadh na n-altraí agus na gcnáimhseach a bhí ag obair in earnálacha éagsúla maidir le saincheisteanna agus téamaí cosúil le cúraim an duine aosta.

I mbliana críochnaíodh sraith alt sa nuachtlitr, ar cuireadh tus léi i 2002, faoi aonaid phleanála agus forbartha altranais agus cnáimhseachais indibhidiúla. I rith na bliana 2003 bhí an Chomhairle Náisiúnta agus na haonaid phleanála agus forbartha altranais agus cnáimhseachais ag obair le chéile i gcomhpháirtíocht chun tacaíocht agus forbairt a dhéanamh ar raon leathan de chlár oideachais leanúnaigh a dhéanann freastal ar riachtanais agus leasanna na n-altraí agus na gcnáimhseach atá ag obair ar fud na seirbhíse sláinte.



## Nursing and Midwifery Planning and Development Units

The National Council continued to hold regular meetings with the directors of the nursing and midwifery planning and development units (NMPDUs) throughout the year. Key strategic development issues formed the agenda for these meetings. Topics for 2003 included the development of clinical nurse and midwife specialist (CNS/CMS) posts and advanced nurse and midwife practitioner (ANP/AMP) posts, development of generalist roles, research, care of the older person across settings and health service reform.

This agenda was progressed through the effective working relationship between the respective staffs of the National Council and the NMPDUs, the groundwork for which has been laid through these regular meetings and through regular formal and informal contact on many professional and procedural issues.

A new format for the regional meetings was implemented in the autumn of 2003, with smaller groups of participants being formed and given an opportunity for discussion at a regional level around the agenda of care of the older person. This approach ensured greater intradisciplinary communication and gave rise to enhanced awareness of the perspective of nurses and midwives working in different sectors on issues and themes such as care of the older person.

A series of features in the newsletter on individual NMPDUs which had commenced in 2002 was completed this year. Throughout 2003 the National Council and the NMPDUs have worked together in partnership to support and develop a wide range of continuing education programmes that meet the needs and match the interests of nurses and midwives working throughout the health service.

## Oideachas Leanúnach

Is cuid mhór d'obair na Comhairle Náisiúnta é leithroinnt an chiste cláir oideachais leanúnaigh. Tháinig forbairt ar an obair seo i gcomhpháirtíocht leis na haonaid phleanála agus forbartha altranais agus cnáimhseachais. Chomh maith leis sin, tháinig an dúthracht agus an dinimiciúlacht ó na haltraí agus na cnáimhseacha a bhí ag obair ag leibhéal áitiúil agus a bhí in ann na hathruithe a bhí ag teastáil chun cur le seirbhísí sláinte othar/cliant lárnach d'ardchaighdeán a shamhlú. I measc na gclár a fuair maoiniú i 2003 bhí idir comhdhálacha aon lae amháin agus tionscadail forbartha chleachtais trí bliana, agus chlúdaigh siad gnéithe éagsúla de chleachtas, bainistíocht, oideachas/oiliúint agus taighde.

Próiseáladh na hiarratais le haghaidh maoinithe de réir an doiciméid *Criteria and Processes for the Allocation of Additional Funding for Continuing Education* (Feabhra 2001). Rinneadh athbhreithniú ar an bhfoirm iarratais oifigiúil i mí Feabhra 2002, agus bhí sé le fáil ach é a iarraidh ón gComhairle Náisiúnta ar an láithreán gréasáin. Tá tuairisc ghairid faoi na cláir oideachais leanúnaigh ar tugadh maoiniú dóibh in 2003 le fáil in aguisín.

### Ionaid Oideachais Altranais

Léiríonn na hionaid oideachais altranais forbairt nua i soláthar oideachais inseirbhíse leanúnaigh d'altraí agus chnáimhseacha ar fud na hÉireann. Tá an Chomhairle Náisiúnta ag forbairt nasc le stiúrthóirí na n-ionad seo agus bhí siad ag comhoibriú leo chun sraith léargas a chur le chéile faoin obair a dhéanann siad don nuachtlitr. Beidh an tsraith seo ag leanúint ar aghaidh i 2004.



## Continuing Education

The allocation of funding to continuing education programmes is a major part of the National Council's work. This work has developed in partnership with the nursing and midwifery planning and development units. Furthermore it has been fuelled by the enthusiasm and dynamism of nurses and midwives working at local level who can envisage the changes required to enhance patient-/client-centred, high-quality health services. Programmes funded in 2003 range from one-day conferences to three-year practice development projects, and cover various aspects of practice, management, education/training and research.

Applications for additional funding were processed in accordance with the document *Criteria and Processes for the Allocation of Additional Funding for Continuing Education* (February 2001). The original application form was revised in February 2002 and was made available on request from the National Council and on the website. A brief description of all continuing education programmes for which funding was approved in 2003 is included in an appendix.

### Centres of Nurse Education

The centres of nurse education represent a new development in the provision of in-service and continuing education for nurses and midwives throughout Ireland. The National Council is developing links with the directors of these centres and has collaborated with them to produce a series of features on their work for inclusion in the newsletter. This series will continue in 2004.

## Tionscadal d'Altraí agus do Chnáimhseacha in Oideas a Thabhairt

Tá an *Review of Nurses and Midwives in the Prescribing and Administration of Medicinal Products Project* á dhéanamh ag an gComhairle Náisiúnta i gcomhpháirtíocht leis An Bord Altranais. Is í aidhm an tionscadail ná athbhreithniú a dhéanamh ar an mbaint a bhíonn ag altraí agus cnáimhseacha in ullmhóidí leighis a thabhairt, ag féachaint do threoirínte a chur le chéile maidir le leighis a thabhairt.

Is iad Yvonne O'Shea, Kathleen Mac Lellan, Marie Keane agus Pearse Finegan ionadaithe na Comhairle Náisiúnta ar an gCoiste Stiúrtha Ildisciplíneach. Bhí ceithre chruinniú ag an gCoiste in 2003. Roghnaíodh sé shuíomh phíolótacha, agus aontaíodh ar chritéir a bhaineann le hoideas a thabhairt i gcomhar le haltraí/cnáimhseacha agus ar chlár oideachais a roghnú.

Reáchtáil Dámha an Altranais/Chnáimhseachais, Leighis agus Cógaisíochta ag Coláiste Ríoga na Máinlianna in Éirinn clár oideachais sé mhí. Baineadh úsáid as formáidí measctha seachadta, teileachomhdháil san áireamh. Chríochnaigh trí altra agus cnáimhseach is tríocha an clár seo.



## Nurse and Midwife Prescribing Project

The *Review of Nurses and Midwives in the Prescribing and Administration of Medicinal Products Project* is being undertaken by the National Council in partnership with An Bord Altranais. The purpose of the project is to review the involvement of nurses and midwives in the prescribing of medical preparations, with a view to producing prescribing guidelines.

Yvonne O'Shea, Kathleen Mac Lellan, Marie Keane and Pearse Finegan represent the National Council on the multidisciplinary Steering Committee. Four meetings of this committee were held in 2003. Six pilot sites were selected, and criteria for nurse/midwife collaborative prescribing and for the selection of education programme were agreed.

A six-month education programme was delivered by the Faculties of Nursing/Midwifery, Medicine and Pharmacy at the Royal College of Surgeons in Ireland. Mixed delivery formats were used, including the use of teleconferencing. Thirty-three nurses and midwives completed this programme.



## Taighde

Ta an Chomhairle Náisiúnta fos díograiseach faoi fhorbairt a dhéanamh ar thaighde sna gairmeacha trí obair an Oifigigh Fhorbartha Taighde, agus is comhcheapachán é seo leis an mBord um Thaighde Sláinte. Tá an obair seo á threorú ag an gcreatlach straitéiseach *Research Strategy for Nursing and Midwifery in Ireland* (An Roinn Sláinte agus Leanaí, 2003). Tá aon mholadh is fiche le fáil sa chreatlach a bhaineann le taighde, ó ghiniúint go húsáid.

Tá cúram ar choiste de chuid na Ranna Sláinte agus Leanaí, atá faoi chathaoirleacht an Phríomh-Altra agus a bhfreagraíonn an Oifigeach Forbartha Réigiúnach dó, le féachaint chuige go gcuirfí an tuarascáil straitéiseach i bhfeidhm. Tháinig an coiste le chéile ar thrí ócáid éagsúla i 2003, agus d'aontaigh siad ar phlean tionscadail cúig bliana, rinneadh tosaíocht ar mholtaí na straitéise agus forbraíodh plean gníomhaíochta. Ag deireadh na bliana bhí ceithre cinn de na moltaí críochnaithe, bhí tús curtha le sé mholadh eile agus tá siad fós ag dul ar aghaidh, agus tá tús le cur le ceithre mholadh eile go luath i 2004. Tá roinnt faisnéise bhunúsáil bailithe cheana féin, agus is féidir an dul chun cinn a chur i gcomparáid leis sin.

Coinníonn an tOifigeach Forbartha Réigiúnach súil leanúnach ar thaighde trí na bealaí cumarsáide atá ag an gComhairle Náisiúnta cheana féin, is iad sin an nuachtlitir, an láithreán gréasáin, cruinnithe réigiúnacha, máistir-ranganna agus an chomhdháil bhliantúil. Bíonn an tOifigeach Forbartha Réigiúnach páirteach i gcruinnithe leis na príomhpháirtithe leasmhara, ag cur stiúrthóirí na n-aonad pleanála agus forbartha altranaís agus cnáimhseachais san earnáil oideachais tríd leibhéal san áireamh. Tharla líonrú náisiúnta agus idirnáisiúnta agus é mar aidhm aige comhaontas a chothú amach anseo agus tá an tOifigeach Forbartha Réigiúnach ag obair go gníomhach le *European Nurse Research Developers* chomh maith le bheith ag obair ar thionscadail a bhaineann le hÉirinn amháin.



## Research

The National Council continues its commitment to developing research in the professions through the work of the Research Development Officer (RDO) who is a joint appointment with the Health Research Board (HRB). This work is guided by the *strategic framework Research Strategy for Nursing and Midwifery in Ireland* (Department of Health and Children, 2003) which contains twenty-one recommendations concerned with research, from generation to utilisation.

A Department of Health and Children committee, which is chaired by the Chief Nursing Officer and to which the RDO reports, is charged with overseeing the implementation of *this strategic report*. The committee met on three separate occasions in 2003, at which a five-year project plan was agreed, the recommendations of the strategy prioritised and an action plan developed. By the end of the year *four recommendations are complete, six have commenced and are on-going, and a further four are due to begin early in 2004*. Some baseline information about research has been gathered, against which progress can be measured.

The RDO continues to profile research using the existing communication channels of the National Council, namely the newsletter, website, regional meetings, master classes and the annual conference. The RDO participates in meetings with key stakeholders, including the directors of the nursing and midwifery planning and development units and the third-level education sector. Both national and international networking has occurred for the purpose of building future strategic alliances and the RDO is actively working with a group of European nurse research developers as well as on all-Ireland initiatives.

## Cumarsáid agus Teagmháil

### An Tríú Comhdháil Náisiúnta – Torthaí Straitéiseacha a Bhaint Amach: An Dúshlán Idirdhisciplíneach

Chuir Yvonne O'Shea, Príomhfheidhmeannach ana Comhairle Náisiúnta tús leis an tríú Comhdháil Náisiúnta, agus ba é Michael Kelly, Ard-Rúnaí na Roinne Sláinte agus Leanaí a thug an spreagaitheasc. Mar a tharla sna blianta roimhe seo, bhí an chomhdháil ar síúl ar feadh dhá lá (19-20 Samhain), rud a thug deis do bheagnach míle cleachtóir freastal air, bualadh leis na láithreoirí agus labhairt leo.

Ba é teideal, téama agus ábhar na comhdhála ná *Torthaí Straitéiseacha a Bhaint Amach: An Dúshlán Idirdhisciplíneach*, bhí an obair idirdhisciplíneach ina príomhthéama sa straitéis sláinte, *Ardchaighdeán agus Cothroime – Córas Sláinte Duitse* (An Roinn Sláinte & Leanaí, 2001) agus *Report of the National Task on Medical Staffing* (An Roinn Sláinte & Leanaí, 2001).

I measc na gcainteoirí agus na gcathaoirleach bhí ionadaithe ón Roinn Sláinte agus Leanaí, An Bord Altranais, Na hAonaid Phleanála agus Forbartha Altranais agus Cnáimhseachais, agus saineolaithe i gcleachtais altranais agus cnáimhseachais agus oideachais go bhfuil cáil orthu go hidirnáisiúnta.

Fuarthas cúig cur i láthair is fiche ar phóstaí ó gach cearn den tír agus ó na rannáin éagsúla den chlár, agus léirigh siad an pháirt a ghlacann na haltraí agus na cnáimhseacha i bhfoirne idirdhisciplíneacha agus chleachtais. Bhí dhá chomórtas póstaí ar síúl dhá lá i ndiaidh a chéile. Bronnadh duaiseanna ar na buaiteoirí agus orthu siúd a tháinig sa dara háit.

### Máistir-Ranganna

Thionóil an Chomhairle Náisiúnta dhá shraith máistir-ranganna in earrach agus fómhar na bliana 2003. Reáchtáladh na ranganna ag ionaid ar fud na tíre agus léirigh siad na hábhair suime agus imní éagsúla a bhí ag altraí agus cnáimhseacha. Tá liosta de na cainteoirí a fuair cuireadh chun freastal ar na ranganna agus na teidil a bhí ar a gcur i láthair le fáil thíos. Bhí a lán daoine ag freastal ar gach rang agus bhí na luachálacha a fuair siad deimhniúil.

## Communication and Contact

### Third National Conference - Achieving Strategic Outcomes: The Interdisciplinary Challenge

The third national conference of the National Council was opened by the Chief Executive Officer, Yvonne O'Shea, and the key note address was delivered by Michael Kelly, Secretary General, Department of Health and Children. As in previous years, the conference content was repeated over two days (19-20 November), enabling almost 1,000 practitioners to attend, meet the presenters and network.

The title, theme and content of the conference was *Achieving Strategic Outcomes: The Interdisciplinary Challenge*, interdisciplinary working being a prominent theme of the Health Strategy, *Quality and Fairness – A Health System for You* (Department of Health & Children, 2001), and the *Report of the National Task Force on Medical Staffing* (Department of Health & Children, 2003).

The speakers and chairpersons included representatives from the Department of Health and Children, An Bord Altranais, the nursing and midwifery planning and development units, and internationally known experts in nursing and midwifery practice and education.

Eighty-five poster presentations were received from all around the country and from the different divisions of the register, and illustrated nurses' and midwives' involvement in interdisciplinary teams and practice. Two separate poster competitions were held on successive days. Prizes were awarded to the winners and runners-up.

### Master Classes

The National Council hosted two series of master classes in the spring and autumn of 2003. The classes were held at venues around the country and reflected the diverse interests and concerns of nurses and midwives. The invited speakers and the titles of their presentations are shown below. There was a high turnout for each class and the evaluations received were affirmative.

The web-based directory of courses offered by third-level institutes in the Republic of Ireland and Northern Ireland was updated during the year. An average of 400 visits per month was recorded in 2003.

By the end of 2003, a total of 539,872 visits to the whole website had been recorded.

#### Newsletter

The National Council continued to distribute its quarterly newsletter to all nurses and midwives on the Register. The Winter 2003 issue was sent to 60,159 nurses and midwives registered with An Bord Altranais.

A further 3,743 copies of each issue were distributed to health service personnel and organisations, higher and third-level education institutions and international nursing/midwifery organisations. The newsletter is also available on the National Council's website.

The main themes of the newsletter in 2003 were the Health Service Reform Programme and awareness of people with disabilities (2003 was European Year of People with Disabilities). Special inserts containing summaries of *Agenda for the Future Development of Nursing and Midwifery* and *Guidelines for Portfolio Development for Nurses and Midwives* were included in the summer and winter issues respectively.

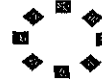

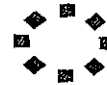

- Forbairt phleananna chun clár oiliúna cúf i gcomhionannas agus éagsúlacht a reáchtáil leis an bhfoireann i 2004.



## Ensuring Equality and Valuing Diversity

The population of Ireland is becoming increasingly diverse and this is reflected among those who use or work in the health system. The Health Strategy, *Quality and Fairness – A Health System for You* (Department of Health & Children, 2001), acknowledged this diversity and proposed a framework for developing human resources to enable staff to adapt to the challenges of diversity. Subsequently the *Action Plan for People Management in the Health Service* (APPM) was developed to provide a clear road map for action in seven interdependent areas, including quality of life (Department of Health & Children, and Health Service Employers' Agency, 2002).

The National Council supports and endorses the notion that the quality of life can be improved by providing equal opportunities and accommodating diversity, thereby recognising the talents and skills of all staff. It also aims to create and maintain a culture that seeks, respects, values and harnesses difference.

### Equality and Diversity Promoting Initiatives in 2003

In accordance with the APPM's Action 2.2 (Ensure equality and value diversity), the National Council has carried out the following equality and diversity promoting initiatives in 2003:

- Production of *Ensuring Equality and Valuing Diversity*, a document for all staff and which sets out the National Council's policy on equality and diversity, and identifies key human resource areas where equality of opportunity can be and is being promoted.
- Revision of the National Council's Staff Manual to reflect equality legislation and to support the principles and relevant actions of the Health Strategy and the APPM.
- Introduction of flexi-time working.
- Inclusion in the National Council newsletter of a series entitled *Disability Awareness* in recognition of European Year of People with Disabilities, with the aim of promoting awareness of the special needs of people with physical, intellectual and mental health disabilities among nurses, midwives and other relevant personnel working in mainstream and primary health care services.
- Development of plans to run an appropriate training programme in equality and diversity with staff in 2004.
- Identification and acquisition of appropriate source and reference material for the development of equality of opportunity policy and policy-implementation activities.

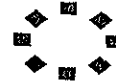

# Report of the Comptroller and Auditor General for presentation to the Houses of the Oireachtas

I have audited the financial statements on pages 71 to 81 under Section 5 of the Comptroller and Auditor General (Amendment) Act, 1993.

## Respective Responsibilities of the Council and the Comptroller and Auditor General

The accounting responsibilities of the Council are set out in the Statement of Council's Responsibilities on page 67. It is my responsibility, based on my audit, to form an independent opinion on the financial statements presented to me by the Council and to report on them.

I review whether the Statement on the System of Internal Financial Control on page 69 reflects the Council's compliance with applicable guidance on corporate governance and report any material instance where it does not do so, or if the statement is misleading or inconsistent with other information of which I am aware from my audit of the financial statements.

## Basis of Audit Opinion

In the exercise of my function as Comptroller and Auditor General, I conducted my audit of the financial statements in accordance with auditing standards issued by the Auditing Practices Board by reference to the special considerations which attach to State bodies in relation to their management and operation.

An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgments made in the preparation of the financial statements, and of whether the accounting policies are appropriate to the Council's circumstances, consistently applied and adequately disclosed.

I planned and performed my audit so as to obtain all the information and explanations that I considered necessary to provide me with sufficient evidence to give reasonable assurance that the financial statements are free from material misstatement whether caused by fraud or other irregularity or error. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the financial statements.

## Opinion

In my opinion, proper books of account have been kept by the Council and the financial statements, which are in agreement with them and have been properly prepared in accordance with accounting policies laid down by the Minister for Health and Children, give a true and fair view of the state of affairs of the National Council for the Professional Development of Nursing and Midwifery at 31 December 2003 and of its income and expenditure for the year then ended.

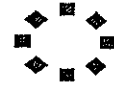

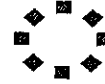

## Statement of Accounting Policies for the Year Ended 31 December 2003

The following accounting policies are applied consistently in dealing with items which are considered material in relation to the Council's financial statements.

### Accounting Convention

The financial statements are prepared under the historical cost convention and comply with the Accounting Standards issued by the Minister for Health and Children.

### Basis of Preparation

Allocations received and receivable from the Department of Health and Children are credited to the Income and Expenditure Account on the basis of the allocated amount notified by the Department of Health and Children to the Council in each financial year.

Expenditure is included in the financial statements on the accruals basis.

### Tangible Fixed Assets and Depreciation

Tangible fixed assets are stated at cost less accumulated depreciation.

Income applied towards the purchase of fixed assets is transferred to the Capitalisation Account and amortised in line with the depreciation of the assets concerned.

Depreciation is provided at rates calculated to write off the cost or valuation less residual value of each asset over its expected useful life, as follows:

Telephone System	12.5% Straight Line
Office Equipment	12.5% Straight Line
Fixtures & Fittings	12.5% Straight Line
